From 2017/18 onwards only the normal rate peg increase will apply.



The Trangie community voted against the special rate variation during a public consultation meeting on Tuesday night.

Trangie residents gathered at the bowling club to meet with the Mayor Bill McAnally, General Manager Greg Lamont, Chief Financial Officer Yvonne Clarke and other members of council to discuss the potential rate increase for the next two financial years.

Council has proposed a 3.5 per cent increase on next year's rates on top of the usual CPI Rate Pegging of three per cent.

Council is currently consulting with the community as part of its application. It believes the rate increase is necessary to qualify for the Fit for the Future package proposed by the current state government.

"We're a stand-alone council and we've proved it. But we need to make these decisions before someone else does," Cr McAnally

The rate variation was not well received by a number of people at the Trangie consultation meeting.

Trangle resident Col Hamilton questioned whether Narromine Shire could work separately to the state government.

"What happens if you tell the State Government to get nicked and run your own show and we really scale back and run like a business?" he asked.

Cr McAnally said he didn't believe it would work on the rates the council currently received.

"Rates income revenue is \$6.55 million and money from the state government in grants and contributions is around \$10 million," CFO Mrs Clarke said.

Many Trangie residents questioned the council's systems and asked whether the council was running efficiently.

Resident Kevin Flynn put the question to the panel.

"The vibes I'm getting are all about efficiencies. I've studied this newsletter at length and once it mentions efficiencies. Yvonne mentioned it once in her address. We know the federal government is in debt of about \$30 billion, the state government owes a lot of money and it's filtering through the system.

"It's exactly the same as any household, if you're spending more than what you're bringing in, something's got to give. I believe what Narromine Shire. Council needs to do is have a really good look at the efficiencies," he said.

The majority of the crowd agreed with him.

Mrs Clarke outlined the special rate variation is one way council could accumulate the funds to be Fit for the Future. Other options include reducing services or selling non-core assets.

"What are the alternatives? Council can reduce services,

always hard. What is an essential service to one part of the community is not to the other. Option two is sustaining our services but increasing our fees and charges, how much can we charge for the hire of a hall or using our facilities when it becomes too high and no

one wants to use it at all?
"Another option is selling off
the non-core assets. This will
become a problem when you
decide what is a non-core asset
that who do we sell it to?" She

Despite the negative reaction to the proposition Cr McAnally maintains it's the best option for council.

The federal government has no money, the state government has no money and they're looking at its to maintain services. It's still date rise and it's a very hard thing to sell," he said.

The mood at the Tomingley meeting was low-key. Cr Tony Ellis told Flat Chat News that the general manager and the mayor explained what the rate increase meant and the people at the meeting accepted what they said.

The Trangie and Narromine meetings were contrary, with the audiences at both these meetings somewhat hostile to the prospect of a rate increase.

Trangie's meeting had a vote of 50 against the rate rise and 20 for it. The Trangie audience expressed concerns about council's systems and efficiencies.

The mayor, Cr Billy McAnally, the general manager, Greg Lamont, and other staff members faced around 50 Narromine residents last Thursday at the meeting held at the Narromine Golf Club.

At this meeting, as with the two previous meetings, Cr McAnally endeavoured to explain why the rate increases were necessary and that it is not councils decision perse but the latest 'incentive' from the State Government, the 'Fit for the Future' package.

"I think Narromine Shire Council can be efficient in the future and a financial council.

"I really think we have to give this (rate increase) a shot. There is nothing popular about rate increases or price rises. Along with the rate rise we are working received," he said.

According to Cr McAnally the State Government has asked all councils to put in for this loan.

"They (State Government) said that local government should borrow more money, but I don't always agree with that," he said.

He explained that the State Government is very good at giving local government funding and then turning around a couple of years down the track and pulling the funding out, causing major problems for councils.

"Originally the rate pegging was going to be set at three percent and the special rate variation was being set at 3.5 percent, but that has gone down to 2.4 percent and we can't go higher than that," he said.

Yvonne Clarke, director of Finance and Corporate Strategy, explained that local government cannot just decide to increase the rates above the rate peg and that councils have to apply to the Independent Pricing and Regulatory Tribunal (IPRAT) to assess the rate increases in full or in part.







community meeting," said Mr Barnett.
"At the October meeting, Council decided to go with this process and as far as I can tell it does not appear that any costings were given to councillors. At the November meeting councillors decided to employ someone to work through the process for six weeks at a cost of \$39,000," he said.

Mr Barnett said that that amount represents about a quarter of what council would have got with the increase.

Mrs Susie Collett told council that she believed they had failed to make a case for the special rate rise through council's newsletter.

"You have given us why you think we should have a special rate rise but I don't think you have made a case for the people who are running their business, their farms and families. There is no justification, just because you can't find efficiencies and your income is not covering your expenditure that you need more or should have more and we will pay forever. That is not a good rationale for doing anything," Mrs Collett said.

She pointed out to council that they did not show the figures to prove that Narromine Shire would be safe and financially stable in 10 years after the special rate increase.

"Amalgamation is used here more a threat than a business management proposal and that's a sad


state of affairs. It should not be a threat and it should be a proper analysis of the benefits it could accrue if Dubbo, Wellington and Narromine were to be amalgamated.

"How can possibly make decision on anything for the future that is financially responsible if you don't look at that, because if down the road, if what you are proposing tonight does not work, we will all be a lot poorer," she said.

Ashley Gilchrest said he agreed with what Mrs Collett said and private "In enterprise the middle to upper level management, where a lot of money is spent on salaries, gets a bit of a clean out from time to time and a business seems to right itself.

"I think if we are going to be fit for the future, we need to lose a bit of fat, that's the way I see it," he said.

Cr McAnally said that it was not a forgone conclusion that council will get the rate increase and asked people to send in submissions and complete the survey.

COUNCIL COLUMN NEXT COUNCIL MEETING

The next Ordinary Meeting of Narromine Shire Council will be held on Wednesday 11 February 2015 in the Council Chambers, commencing at 4.00 pm.

NARROMINE SHIRE COUNCIL SPECIAL RATE VARIATION PROPOSAL - UPDATE

In consideration of the feedback received and financial requirements, Council resolved at its December 2014 meeting to reduce the proposal for Special Rate Variation to a 5.9% rate increase for 2015/16 (comprising the 2.4% rate peg as now determined by the State Government for 2015 plus an additional 3.5%) and 6.5% for 2016/17 (comprising 3% typical rate peg plus an additional 3.5%). This variation gives Council \$170,000 income in the first year and \$185,000 income in the second year.

In summary, if the proposal proceeds, there would be two years of increases to general rates from 2015/16 to 2016/17. In the following year (ie 2017/18) the revised total rate would increase by the normal rate pegging percentage (estimated at 3% per annum). This means that the increases for 2015/16 and 2016/17 remain as a permanent increase to general rates.

The cumulative percentage increase to rates over the two years will be 12.78%, whereas without the Special Rate Variation of the additional 3.5%, the cumulative increase over the two years would be 5.47%.

The proposed increase addresses recommendations in recent NSW State Government reviews and is important for long term financial sustainability and to maintain Council services to the community as Council strives to be "Fit for the Future".





Council Notes

Closure of O'Neill Square: Council wishes to advise that due to work being undertaken in the area, Council has developed a traffic management plan which will necessitate the closure of O'Neill Square for a period of time. This closure is effective from Wednesday, 12 November, 2014. This traffic management plan has been developed in conjunction with the RMS due to the Mitchell Highway being located within the area of works. The purpose of closing O'Neill Square is for both the safety of the workers and also the safety of the traffic. The traffic speed will be reduced as well and all heavy vehicles will be encouraged to use the new heavy vehicle route on the southern side of town for the duration of the work.

O'Neill Square Bus Stop: The bus stop normally located at O'Neill Square (Stop number 2) has been relocated to in front of the Narromine Swimming Pool on Burroway Street for the duration of the proposed Civil Works. Council has held meetings in Tomingley (8-10 people attended), Trangie (70 people) and Narromine (50 people) to present their case.

The mood at the Tomingley meeting was low-key. Cr Tony Ellis told Flat Chat News that the general manager and the mayor explained what the rate increase meant and the people at the meeting accepted what they said.

The Trangie and Narromine meetings were contrary, with the audiences at both these meetings somewhat hostile to the prospect of a rate increase.

Trangie's meeting had a vote of 50 against the rate rise and 20 for it. The Trangie audience expressed concerns about council's systems and efficiencies.

The mayor, Cr Billy McAnally, the general manager, Greg Lamont, and other staff members faced around 50 Narromine residents last Thursday at the meeting held at the Narromine Golf Club.

At this meeting, as with the two previous meetings, Cr McAnally endeavoured to explain why the rate increases were necessary and that it is not councils decision perse but the latest 'incentive' from the State Government, the 'Fit for the Future' package.

"I think Narromine Shire Council can be efficient in the future and a financial council.

"I really think we have to give this (rate increase) a shot. There is nothing popular about rate increases or price rises. Along with the rate rise we are working received," he said.

According to Cr McAnally the State Government has asked all councils to put in for this loan.

"They (State Government) said that local government should borrow more money, but I don't always agree with that," he said.

He explained that the State Government is very good at giving local government funding and then turning around a couple of years down the track and pulling the funding out, causing major problems for councils.

"Originally the rate pegging was going to be set at three percent and the special rate variation was being set at 3.5 percent, but that has gone down to 2.4 percent and we can't go higher than that," he said.

Yvonne Clarke, director of Finance and Corporate Strategy, explained that local government cannot just decide to increase the rates above the rate peg and that councils have to apply to the Independent Pricing and Regulatory Tribunal (IPRAT) to assess the rate increases in full or in part.

"In some cases they will not approve it at all if councils cannot fully justify why they are seeking this increase," she said.

"Each council must now prove that they are sustainable into the future, the State Government is calling it 'Fit for the Future'," she said.

According to Ms Clarke, Narromine Shire Council could lose \$3.5m over the next 10 years due to the four year freeze by the Federal Government to give any assistance.

"This is a lot of money for a small rural council to lose. This will result in operating deficits over this period and beyond," she said.





Along with the rate rise we are working on efficiencies and make sure we do complete jobs efficiently the first time, so we don't have to go back and do it again," Cr McAnally, said.

"We have also put in an application into the State Government for a low interest loan for \$3 million and which we

borrow more money, but I don't always agree with that," he said.

He explained that the State Government is very good at giving local government funding and then turning around a couple of years down the track and pulling the funding out, causing major problems for councils.

"Originally the rate pegging was going to be set at three percent and the special rate variation was being set at 3.5 percent, but that has gone down to 2.4 percent and we can't go higher than that," he said.



"At the October meeting, Council decided to go with this process and as far as I can tell it does not appear that any costings were given to councillors. At the November meeting councillors decided to employ someone to work through the process for six weeks at a cost of \$39,000," he said.

Mr Barnett said that that amount represents about a quarter of what council would have got with the increase.

Mrs Susie Collett told council that she believed they had failed to make a case for the special rate rise through council's newsletter.

"You have given us why you think we should have a special rate rise but I don't

think you have made a case for the people who are running their business, their farms and families. There is no justification, just because you can't find efficiencies and your income is not covering your expenditure that you need more or should have more and we will pay forever. That is not a good rationale for doing anything," Mrs Collett said.

She pointed out to council that they did not show the figures to prove that Narromine Shire would be safe and financially stable in 10 years after the special rate increase.


"Amalgamation is used here more as a threat than a business management proposal and that's a sad state of affairs. It should not be a threat and it should be a proper analysis of the benefits it could accrue if Dubbo, Wellington and Narromine were to be amalgamated.


"How can you possibly make a decision on anything for the future that is financially responsible if you don't look at that, because if down the road, if what you are proposing tonight does not work, we will all be a lot poorer," she said.

Ashley Gilchrest said he agreed with what Mrs Collett said and added, "In private enterprise the middle to upper level management, where a lot of money is spent on salaries, gets a bit of a clean out from time to time and a business seems to right itself.

"I think if we are going to be fit for the future, we need to lose a bit of fat, that's the way I see it," he said.

Cr McAnally said that it was not a forgone conclusion that the council will get the rate increase and asked people to send in submissions and to complete the survey.

The Trangie community voted against the special rate variation during a public consultation meeting on Tuesday night.

Trangie residents gathered at the bowling club to meet with the Mayor Bill McAnally, General Manager Greg Lamont, Chief Financial Officer Yvonne Clarke and other members of council to discuss the potential rate increase for the next two financial years.

Council has proposed a 3.5 per cent increase on next year's rates on top of the usual CPI Rate Pegging of three per cent.

Council is currently consulting with the community as part of its application. It believes the rate increase is necessary to qualify for the Fit for the Future package proposed by the current state government.

"We're a stand-alone council and we've proved it. But we need to make these decisions before someone else does," Cr McAnally said.

The rate variation was not well received by a number of people at the Trangie consultation meeting.

Trangle resident Col Hamilton questioned whether Narromine Shire could work separately to the state government.

"What happens if you tell the State Government to get nicked and run your own show and we really scale back and run like a business?" he asked.

Cr McAnally said he didn't believe it would work on the rates the council currently received.

"Rates income revenue is \$6.55 million and money from the state government in grants and contributions is around \$10 million," CFO Mrs Clarke said.

Many Trangle residents questioned the council's systems and asked whether the council was running efficiently.

Resident Kevin Flynn put the question to the panel.

"The vibes I'm getting are all about efficiencies. I've studied this newsletter at length and once it mentions efficiencies. Yvonne mentioned it once in her address. We know the federal government is in debt of about \$30 billion, the state government owes a lot of money and it's filtering through the system.

"It's exactly the same as any household, if you're spending more than what you're bringing in, something's got to give. I believe what Narromine Shire Council needs to do is have a really good look at the efficiencies," he said.

The majority of the crowd agreed with him.

Mrs Clarke outlined the special rate variation is one way council could accumulate the funds to be Fit for the Future. Other options include reducing services or selling non-core assets.

"What are the alternatives? Council can reduce services,

always hard. What is an essential service to one part of the community is not to the other. Option two

is sustaining our services but increasing our fees and charges, how much can we charge for the hire of a hall or using our facilities when it becomes too high and no one wants to use it at all?

Another option is selling off the non-core assets. This will become a problem when you decide what is a non-core asset and who do we sell it to?" She

Despite the negative reaction of the proposition Cr McAnally maintains it's the best option for council.

The federal government has no money, the state government has no money and they're looking at its to maintain services. It's still affice rise and it's a very hard thing to sell," he said.

The application will be made to the Independent Pricing and Regulatory Tribunal next year and that the power to reject the additional rate variation.

NARROMINE SHIRE COUNCIL SPECIAL RATE VARIATION PROPOSAL - UPDATE

In consideration of the feedback received and financial requirements, Council resolved at its December 2014 meeting to reduce the proposal for Special Rate Variation to a 5.9% rate increase for 2015/16 (comprising the 2.4% rate peg as now determined by the State Government for 2015 plus an additional 3.5%) and 6.5% for 2016/17 (comprising 3% typical rate peg plus an additional 3.5%). This variation gives Council \$170,000 income in the first year and \$185,000 income in the second year.

In summary, if the proposal proceeds, there would be two years of increases to general rates from 2015/16 to 2016/17. In the following year (ie 2017/18) the revised total rate would increase by the normal rate pegging percentage (estimated at 3% per annum). This means that the increases for 2015/16 and 2016/17 remain as a permanent increase to general rates.

The cumulative percentage increase to rates over the two years will be 12.78%, whereas without the Special Rate Variation of the additional 3.5%, the cumulative increase over the two years would be 5.47%.

The proposed increase addresses recommendations in recent NSW State Government reviews and is important for long term financial sustainability and to maintain Council services to the community as Council strives to be "Fit for the Future".
