Re: Notification of Intention to Apply - Special Rate Variation 2016/17

Dear Mr Harmstorf,

This letter serves as formal notification from Wagga Wagga City Council of its intention to apply for a Special Rate Variation (SRV) for 2016-2017.

The major elements of Council's SRV application are detailed below:

## 1) Type of Special Variation – S508 (2)

Council will be submitting a SRV of 5.63% for 2016/17 maintained for a temporary period of 5 years i.e. last year of retention would be 2020/21.

At the end of the 2020/21 rating year Council plans to return to the applicable rating level for 2021/22 that would have applied had a Special Rate Variation not been approved and Council had taken up only the permitted rate cap each year for the period of Special Rate Variation.

In summary Council will be submitting a SRV that applies the following rate increases:

## 2) Purpose of Special Rate Variation

As noted in Council's 2015/16 Delivery Program & Operational Plan Council will be applying for a Special Rate Variation of 3.83% plus the announced rate peg for 16/17 i.e 1.8% maintained for 5 years to fund its 1/3 share of the costs associated with upgrading the Main City Levee to a 1 in 100 year level of protection and upgrade the North Wagga Levee to a 1 in 20 year level of protection.

The latest Cost Estimates for the Levee Upgrade works as prepared by the NSW Public Works is \$23.3M.
