Re: NOTIFICATION OF INTENTION TO APPLY FOR A SPECIAL RATE VARIATION FOR 2017/2018

MidCoast Council wishes to advise the Independent Pricing and Regulatory Tribunal (IPART) of its intention to apply for a Special Rate Variation for 2017/18. Having completed community consultation, Council considered a report on the matter at its meeting of 23 November 2016 and resolved to proceed with the process by giving IPART the required notification.

Council will be seeking a special variation to its general income under section 508A of the Local Government Act 1993. As a merged Council the rating structure applied to former Council areas must remain. As a result the proposed Special Rate Variation is shown in relation to each former Council area. The proposal is for the following permanent increases.

Great Lakes has an environmental levy of 6% due to expire in 2019/20. It is intended to renew this as part of the application in 2017/18 on an ongoing basis.

Gloucester has an existing SRV approval for a 3 x 13% increase with the final year being 2017/18. It is proposed that the final year of the 3 x 13% be foregone and replaced by the 4 x 5% and the addition of a 6% environmental levy for consistency across the MidCoast Council area.

The purpose of the special variation is to facilitate infrastructure maintenance and renewal programs.
