Schedule 2 - Operations Requirements and Protocols

- (a) The Operations Requirements and Protocols must be agreed between the Parties no later than 60 Business Days prior to the Operations Date.
- (b) The Operations Requirements and Protocols must include, at a minimum, the following content:
 - (i) maintenance protocol, including procedures for scheduling and coordinating maintenance of the Pipeline and Essential Water Facilities;
 - (ii) communication protocol;
 - (iii) incident management protocol;
 - (iv) raw water quality requirements protocol, including procedures for monitoring, sampling and testing water and laboratory testing requirements;
 - (v) water quantity measuring protocol, including principles for calculating under or overpayments;
 - (vi) information management protocol, including procedures for sharing of results of testing and monitoring;
 - (vii) operational changes protocol, including procedures for suspending the operation of the Pipeline;
 - (viii) access to assets and lands protocol; and
 - (ix) systems configuration protocol.
- (c) The Parties agree that they shall negotiate diligently and in good faith any proposed amendments to the Operations Requirements and Protocol to ensure that it meets the requirements of Law and Approvals in a cost effective manner and is finalised as quickly as possible.
