Subject

Fit tor the Future Submission to IPART

Resolved Unanimously

- A. THAT Council adopt the Fit for the Future submission presented with this report, noting that the report demonstrates the Council is Fit for the Future against the Independent Pricing & Regulatory Tribunal (IPART) assessment criteria.
- B. THAT the submission be lodged with IPART by 30 June 2015.
- C. THAT it be noted the Council's adopted position reflected in the submission is to pursue Woollahra Council remaining a stand-alone Council, after considering a range of merger options, on the basis that:
 - i. There is overwhelming community opposition to amalgamation and Council has responded to that opposition
 - a) 91% support keeping our local identity
 - b) 81% want Woollahra to remain a stand-alone council
 - c) 80% oppose any forced amalgamation
 - ii. There are no tangible benefits for Woollahra residents under amalgamation that cannot be delivered, or that are already being delivered under the current structure.
 - iii. NSW Treasury Corporation has confirmed that Woollahra is financially sustainable now and into the future.
 - iv. Woollahra meets five (5) of the seven (7) Fit for the Future quantifiable measures now and will meet all seven (7) by June 2016. This is four (4) years ahead of the 2020 target date.
 - v. Independent financial analysis indicates that none of the merger options achieve all seven (7) Fit for the Future measures.
 - vi. Amalgamation will result in significant and unacceptable rate rises for Woollahra ratepayers under current legislation with those increases funding rate decreases in Randwick.
 - vii. Pensioner rates will increase as they are not protected under current rating legislation.
 - viii. There is clear evidence in the State Government's 'A Plan for Growing Sydney December 2014' that target infrastructure works for the Sydney Central Region are not in the Woollahra LGA and it is highly likely that additional funds generated through significant and unfair rate increases for ratepayers in Woollahra will be redirected under amalgamation to Randwick to progress major infrastructure projects.

- D. THAT the Council continues to pursue its very strong opposition to any forced amalgamation of Woollahra Council.
- E. THAT the Council's submission be provided to The Member for Vaucluse, the Hon. Gabrielle Upton MP, The Member for Sydney, Alex Greenwich, and the Federal Member for Wentworth, the Hon. Malcolm Turnbull MP.
- F. THAT a copy of the submission also be provided to the Mayors of Randwick, Waverley, Botany Bay and City of Sydney Councils.
- G. THAT the General Manager be authorised to make any minor amendments to the submission prior to lodgement.
- H. THAT Council's appreciation and thanks be extended to Professor Gary L. Sturgess for his work in authoring Woollahra Council's Existing Structure Fit for the Future Business Case and for his attendance at Council's Extraordinary Meeting on 29 June 2015.


Background

The NSW Government is undertaking a *'Fit for the Future'* Local Government Reform Program. Woollahra Council may be forced to amalgamate with the City of Sydney, Randwick, Waverley and Botany Bay Councils to form a new 'Global City' Council, expected to have a combined population of more than 500,000 residents – the population of Tasmania.

Waverley Council supports a three council amalgamation with Randwick and Woollahra. This amalgamation will effectively be a takeover of our municipality and would see annual Council rates rise by 22% to 53%, resulting in a total increase between \$7 million to \$17 million per year, based on the NSW Government rating legislation.

These rate increases equate to a total sum of between \$70 million and \$170 million over the next 10 years – effectively transferring money from the pockets of Woollahra ratepayers to the pockets of adjoining ratepayers, the majority of whom are in Randwick.

The rate increases represent a significant, unjustifiable and unacceptable redistribution of rate revenue to Randwick ratepayers. This will occur because the average land value of a residential property in Woollahra is 2.2 times (222%) above the average land value of a residential property in Randwick and 1.7 (171%) above Waverley (see graph below).

HIGH-PROFILE Woollahra ratepayers have given a resounding "no" to their council amalgamating.

And Woollahra Council last night launched a campaign to mobilise opposition to the State Government's Fit for the Future program.

Wentworth Courier surveyed prominent residents from Aussie executive chairman John Symond to former Rooster Anthony Minichiello and all agreed Woollahra had to retain its distinctive identity and fight against rate rises and loss of representation and services.

A WHO'S who of the Woollahra community has come out in support of their council and sent a strong message of no amalgamations.

From fashion designers to real estate royalty, respected experts in their fields have pushed for Woollahra Council to stand alone.

The Wentworth Courier survey comes as the council last night ramped up its campaign for independence.

More than 60 community groups attended a meeting with councillors to hatch a plan for an ongoing antiamalgamation push.

And even those who are outspoken about overgovernance, such as busi-

nessman Theo Onisforou and Aussie Home Loans boss John Symond, have backed the council.

Mr Symond said he had a "general view that in Australia we are over-gov-erned". But he could not support Woollahra being merged unless services increased and rates did not.

Mr Onisforou, owner of the Intersection shopping strip on Oxford St, opposed a merger unless it was with City of Sydney because "it is the wealthiest council in Australia ... if it is not with them I am against it.'

Joint chairman of Ray White real estate, Brian White, said: "One of the fabulous things about Woollahra Council is it has adopted very distinctive identity with its district and the interaction (with) residents is auite unique".

Channel 7 commercial director Bruce McWilliam said he feared quality of service would fall in a merger.

"You can only assume we will lose out if we became part of a broader local government area," he said.

Entertainer Vince Sorrenti was dead serious: "Amalgamation is a great deal for Waverley and Randwick, who clearly need us more than we need them."

Peter Wilding, managing director of Royal Hotels Australia, owner of the Inter-Continental Hotel Double Bay, said a merger was bad news for his business: "We

feel there is something unique in Double Bay in the way the council embraces the village ethos."

Former Roosters captain Anthony Minichiello has swapped the sands of Bondi for the views of Vaucluse. Now he wants neighbouring councils to keep their "hands off Woollahra".

Media commentator Prue MacSween feared it would mean "heavy rate rises and less representation"

Owner of Catalina restaurant Michael McMahon said the support he had received from Woollahra Council was second to none. He said: "The council has

always helped us and been most supportive. We would never get that support from a merged super council.'

Royal Australian Yacht Club commodore John Barbouttis said: "Each of the Woollahra, Waverley and Randwick municipalities have their own individual identities and that would not continue with amalgamation.'

Public relations specialist Ro Markson said the council "invests in the local area, provides good councillor representation and has a deep understanding of issues peculiar to living on the harbour foreshore".

Former Private Secretary of Prime Minister John Gorton Ainslev Gotto said it "should be left alone to continue doing the good job it is doing."

Co-founder of Sass and Bide Sarah-Jane Clarke said the council had "always responded quickly to our neighbourhood needs" and a merger would not provide the same level of service or understanding.

Mark Moran is building a retirement village at Vaucluse. He said locals would suffer if they lost the "professionalism of the council and its officers " which is not "reflected in the other connected government bodies". Founder of fashion and

lifestyle blog, *The Daily Ed-ited*, **Alyce Tran** said the councils should be left separate. Investment banker and director of Pacific Road Capital Management Paul Espie said the council's "independence, local character and culture ... are essential parts of the rich fabric of our society."

Former NFL player Col Scotts argued locals would "lose our voice in a merged council"

Principal of Raine and Horne Double Bay and Bondi Beach **Ric Serrao** said he had "seen what happens when councils get bigger and I feel a lot of issues fall through the cracks".





Invitation from the Mayor of Woollahra to an Information Forum on Council Amalgamation Tuesday 2 June 2015 7.00 pm

I write to you in relation to an important matter impacting upon the future of our Woollahra Municipality – NSW Government's '*Fit for the Future*' Local Government Reform Programme. The recommendation for Woollahra Council under the reform program is that we amalgamate with the City of Sydney, Randwick, Waverley and Botany Bay Councils to form a new 'Global City' Council, expected to have a combined population of 670,000 residents by 2030.

Council has voted unanimously to oppose this proposal.

Faced with this recommendation for amalgamation, Woollahra Council must submit a proposal to the State Government by 30 June 2015, demonstrating that it is *"Fit for the Future"* against the Government's established assessment criteria.

The four (4) criteria are:

- 1. Scale and Capacity
- 2. Sustainability
- 3. Effectively managing infrastructure and delivering services for communities
- 4. Efficiency

The Independent Pricing and Regulatory Tribunal (IPART) have recently been appointed by the Government as the Expert Panel to undertake the assessment of council submissions against these criteria. IPART's determinations on whether councils are 'Fit' for the future or 'Unfit' will be reported directly to the State Government by the end of October, 2015.

Council has no concerns about meeting the seven (7) quantifiable measures that comprise criteria 2, 3 and 4 above.

However the State Government has determined that Scale and Capacity (Criteria 1 above) is the '**threshold**' criteria that submissions must first address. For Woollahra Council, this means that we must present a business case that demonstrates our proposal to stand-alone is 'superior' to the recommendation that we amalgamate into the new Global City Council.

We are aware that Randwick and Waverley Councils are seriously considering a merger proposal for themselves, with a further option to include Woollahra. Our Council will not entertain this option and plans to vigorously oppose any move in this direction. More specifically, Randwick Council's own modelling shows that, due to high land values in the Woollahra area, Woollahra ratepayers would face increases in annual rates of between 22% and 53%. Many properties in Woollahra will see a rate rise in excess of \$10,000 per year if a Randwick, Waverley and Woollahra merger was to proceed.

This rate increase equates to an amount between \$70 million and \$170 million over 10 years out of the pockets of Woollahra ratepayers in a Woollahra, Randwick, Waverley merger, if the Randwick and Waverley rating structures are applied.

These increases in rates in Woollahra will fund equivalent rate decreases for residents in Randwick.

This is totally unacceptable even in the event of any cost savings that 'may' result from that merger and for which there is no guarantee.

Our reasons for opposing any amalgamation are supported by:

- confirmation of Council's financial sustainability through a positive financial sustainability outlook rating from NSW Treasury Corporation,
- financial analysis and conclusions on merger options by the independent consultants Grant Thornton, and
- already strong community support for Woollahra Council to remain a stand-alone Council.

As this is a matter of unprecedented concern for the future of our Municipality, I am inviting you to an information forum I am holding with other community leaders and representatives at 7.00 pm on Tuesday 2 June 2015 at the Redleaf Council Chambers, 536 New South Head Road, Double Bay. If you are not able to attend, we would be very pleased for you to send a representative of your group or organisation.

The following questions were asked:-

Councillor Bennett asking:

I noticed that on O'Sullivan Road a few of the boats have permits issued by Council to park the boats. Are we obliged to issue parking permits to boat owners in O'Sullivan Road and why?

Director Technical Services in response:

Madam Mayor, in brief there is quite a bit of history to this issue. When the Council introduced time limited parking in O'Sullivan Road which was done precisely to move on the boats there was a bit of push back from boat owners who lived in the street. So as a one-off at the time Council agreed that on that one site, the only site in the LGA, Council would issue permits to the boat owners who lived there to enable them to park boats in that street. It only applies to people who live on O'Sullivan Road.

Councillor Petrie asking:

Madam Mayor I have a series of questions. It relates to a letter that you received from Mayor Sally Betts from Waverley.

Mayor in response:

I only saw this letter at about five o'clock. It came into my inbox probably at about two thirty. Because I was having back to back meetings I only saw it quite late. I haven't had a huge amount of time to digest it but go ahead.

Councillor Petrie further asking:

Mayor Betts raises in paragraph two of her letter, which you have and I quote "the increase [in rates] of the magnitude that you suggest", being you Madam Mayor, "was the result of only one of fifty scenarios discussed by the three Councils".

My question to you is if Woollahra's unique rate system of 50% base rate and 50% ad valorem is changed to the singular ad valorem rating system of Randwick and Waverley, how is it possible for your statement that the majority of ratepayers in the Woollahra Municipality will get increases in their rates between \$1,000 and \$30,000 per annum, to be wrong?

Mayor further in response:

If you look at the brochure it says 5,500 properties will increase from \$1,000 to \$10,000 and then there will be some that will increase by as much as \$30,000 per annum. I don't think that we overstated what the impacts are going to be.

Councillor Petrie further asking:

Just to reiterate to give you some more opportunity to respond, if Woollahra's unique rates system of 50% base rate and 50% ad valorem becomes a singular ad valorem valuation between the Councils, how is it possible that your scenario and what you have pointed out is not correct?

Mayor further in response:

In fact if it became full ad valorem it would be higher than the scenario that I put forward. I will pass it to the General Manager to comment further.

General Manager responding:

Madam Mayor during this process Randwick modelled something like eighty (80) different scenarios, some of them within existing legislation, some of them outside of the current legislation, which would require appropriate changes.

What we have said all the way through this is that in the modelling we looked at our current modelling for Woollahra, we looked at the modelling and the current minimum rate for Waverley and we looked at the current modelling for Randwick with their minimum rate.

The scenario that we refer to is the difference that occurs between modelling ours, that is the base rate and that's where the smallest increase actually occurs, in the tune of about \$7 million, right up to the 53% which I think is the Randwick modelling [correction to Waverley Modelling] if their minimum rate is concerned. So we did look at all of them but the modelling that is referred to is based on the modelling that is in place at this point in time.

The reasoning behind that is that we presumed that each of those Councils would be in tune with what is the most appropriate rate modelling for that particular area. We said that if that was to apply across the whole of the merged area that would be the impact.

We were drawing attention to the fact in that based on representation of a newly merged Council, that our chances of pushing for a 50% rates base would be reduced purely and simply on the basis of representation. That is we would only have probably 3 Councillors out of 12. There would be 9 in the other areas which are strong advocates for minimum rates. So that is where those numbers actually come from.

Mayor further asking:

So the reduced representation of 3 Councillors out of 12 would mean that we would not be able to uphold that when it would disadvantage the others to go into our rating structure.

General Manager further responding:

The other point that I would like to make just in clarification, is having seen the letter there is a reference to a rating proposal in there that does not currently exist. That is a 70% base rate and that 70% base rate would require a change in legislation. I would also indicate that within that letter that in fact Waverley's rates do in fact increase under that particular scenario if that was actually dealt with.

Mayor further in response:

Just before you also go on Councillor Petrie I just want to bring attention as you brought it to the letter. In paragraph 3 where is says (and it has been written directly to me but it was circulated to the other Councillors): "I know that you were aware that these discussions have taken place with the State Government as you and I have also discussed". Now can I just elaborate on that further. I am certainly not aware and not privy to discussions going on between other Mayors and the State Government.

I have certainly gone to see my State and Federal Members to discuss the impacts on Woollahra. I have not gone anywhere beyond that. So I am not aware or privy to the discussions going on and any undertakings having been given if they are not public.

If they are not public and formalised I cannot take those into account when distributing information to anyone because they are not concrete. I am not aware of the discussions.

Councillor Betts also says that "there have been discussions between myself and herself and our General Managers etc. etc." I have to go back to the question asked by Councillor Matthew Robertson. [at a previous Council meeting]. Have I had any of these discussions with Councillor Betts? I have not entered into any discussions on amalgamations with Councillor Betts. I have met her at WAYS and other functions but I have never gone into discussions with Councillor Betts at any time regarding these.

The last time we spoke formally about amalgamations was when the General Manager and the Acting General Manager and I had a meeting which was probably the third meeting in a line to look at the model that was actually proposed by Randwick, to see how it panned out for us.

Now there are also accusations that I withheld information from Councillors. You must be aware and some Councillors have identified immediately when they received this letter, that I circulated the model that was proposed by Randwick as soon as we received it and you had every opportunity to have input which you did.

I felt that this letter which was circulated to all of you and was also circulated to me did not really cover the situation correctly at all.

Now Councillor Petrie go ahead.

Councillor Petrie asking:

Madam Mayor, this question requires a different answer.

Did you and Senior Staff ever agree to quote Mayor Betts, "That the three Councils preferred transition option would be for all three Councils to retain their own rating systems of rates for the first term of the new amalgamated Council". Considering we have opposed any forced amalgamation between the three Councils, is this true?

Mayor in response

No it is not true. Under no circumstance have we ever committed to a merger with those two Councils. We certainly undertook some modelling together. I thought that that was fair and it was something that was committed to before I became the Mayor.

There has never been an undertaking that we had a preferred option other than to stand alone and the reason for that is very clear. I certainly would not have made an undertaking on behalf of my community. Firstly, when I entered the mayoral role there was a pre-exsiting survey that already said that our community was 84% against amalgamations. There is no way that we would have had a preferred position that that's what we were going to have, whether it was in transition or otherwise.

Secondly, in all honesty if there was some conversation about tranistion I cannot imagine that the Councils themselves would have been able to ask the State Government to freeze their rates for any period of time so I do not know how that comment could be made at all.

Councillor Petrie asking:

My final question. Madam Mayor are you aware of Minister Toole's statements as quoted in the Daily Telegraph on the 21st May 2015?

He is quoted as saying, "The accumulated budget of NSW Councils is \$12 billion per annum." He then goes on to say that that "\$12 billion dollars could build 24 major hospitals, a harbour tunnel or 5 airports a year".

Does this say that Minister Toole is suggesting that all Councils should be abolished? The only way he is going to get \$12 billion every year to build 24 hospitals, a harbour tunnel or 5 airports is to abolish all Councils.

My question to you is maybe you could ask for clarification to his statement? The statement, apart from being absurd, is suggesting that he is abolishing all Councils.

Mayor in response

Can I say that I am aware of that bit of material in the media. What he is actually proposing is that the cost saving out of the mergers through the IT departments and otherwise would have a cost saving of 15% through Councils.

But if you look at the City of Sydney who merged with South Sydney, they are still so many years down the track, it is almost a decade or more. They have not got their IT divisions under control. So I actually disagree with that statement completely. It is not backed up with any evidence.

Councillor Cavanagh asking:

Last February I proposed a motion which was passed to fast track business development applications. Would you please update the Councillors on the progress to fast track development applications and if the process is now in place? Given the difficult trading times, especially in Paddington, this was urgent then and it is even more urgent now.

Director Planning and Development in response:

Madam Mayor I will take that on notice. The answer is a more complex one than it might seem. I think it is better if I do take it on notice.

Councillor Marano asking:

Madam Mayor, to follow up on Councillor Petrie's comments and tonight's debate, will you be writing to Mayor Sally Betts with the correct information regarding the potential rate rises?

Mayor in response:

I received the letter quite late in the piece. I have asked the General Manager that we make a response formally to her tomorrow. We will try and do that in the first part of the day. What I don't want Councillors, given that we are dealing with preserving our Council, is for it to be a slanging match between Mayors. I have never believed in that kind of approach under any circumstances.

I am getting the feeling from the Councillors that received the letter from Mayor Sally Betts that I must respond to the letter. I am very comfortable to respond. I feel that I have answered a lot of the questions directly relating to the letter this evening. I am very happy to make a formal response to Mayor Sally Betts by midday tomorrow.

Councillor Petrie further responding:

Can I just follow on from Councillor Marano's question to you. Can I suggest that the questions for the next meeting relating to this issue and responses from you Madam Mayor which will become part of the minutes of this meeting be sent to the Mayor of Waverley and also the Mayor of Randwick?

You made replies Madam Mayor which are very important to the way that this Council feels. Can I reiterate that rather than send a letter to Mayor Betts, that the minutes of this meeting and your responses should be sent to the Mayor of Waverley and Randwick?

Mayor further responding:

Yes I think that we will do that. If you don't mind I will include the General Manager's input as well as he attended the meetings with me. I have not had any private meetings. The meetings I attended were also attended either by the General Manager or the Director Corporate Services. I do give an undertaking that we will have a letter out to Mayor Sally Betts by midday tomorrow.

Councillor O'Regan asking:

Can you please advise as to the status of the use of the Lough Playing Fields. I understand that there have been a number of complaints lodged, particularly about the soccer being played there on a Sunday. What (if any) issues have been raised?

Has the Council taken any action or is it intending to change the access or use of those fields? If there is any proposed change to the current use, will that actually involve some community consultation?

Director Technical Services in response:

Madam Mayor, firstly I will refer the Councillors to an email sent by Paul Fraser, Council's Manager, Open Space and Trees which was sent to all Councillors this afternoon relating to this issue.

The upshot is there is a group called the Goal Sport Academy. This group has been using the Lough Playing Fields during summer and winter, with a fairly high degree of intensity.

Yes, there were some complaints from the local community about that intensity of use.

As a consequence staff from Council went and had a look at the site on a Sunday. They spoke to the Academy about their usage of the fields. It was agreed after those discussions by Council staff and members of the Academy that a way forward would be for the summertime activity to be transferred to Lyne Park.

My understanding is that the Academy is very happy with this arrangement. Prior to this being advised to the Academy and the parents, a lot of emails were forwarded to Councillors as there was an understanding that something was going to be decided tonight. This was never the case. Hence the volume of emails.

As of this afternoon our staff have been in contact with the Academy and an agreement has been reached for the Academy to use the Lough Playing Fields in winter and move to the Lyne Park in summer. I understand that both parties are very happy with this arrangement.

The complaints were about parking and intensification of use and noise, generally the sorts of complaints that come with high intense sports field use.

I hasten to add though that Council staff are not of the view that the goal soccer firm did anything wrong. We have a great relationship with them and they are truly professional.

Final Commentary from the Mayor:

Before I close this evening there is one thing that I have not said with regards to the communications that our three Councils (Woollahra, Waverley and Randwick Councils) had when we started doing the modelling.

I feel that I need to make this known. One would ask why our Council would be interested in going into discussions with Randwick and Waverley regarding a three council merger when our community was saying that they were opposed to merging?

We approached it in this way. To best represent the interests of our community we needed to be open to options put to us to see if there were any benefits. We went with an open mind and if there were any benefits then we would make those known to the community of Woollahra.

If the community felt that they wish to support those then we would support the community on that.

However through our communications and going to those meetings we found it very difficult to find any benefits for the community of Woollahra.

We found a level of cost shifting where the rates of Woollahra would in fact cross subsidise works happening in other council areas. We didn't think that was fair or equitable for our local residents.

This is why we originally entered into those discussions, negotiations and modelling, thinking that there might be something in it. Instead of the Global City Model, we looked at this smaller model to see if there was anything in it for Woollahra. It just didn't shape up, it didn't stack up for our Woollahra ratepayers. In the end they are whom we are elected to serve.

Additional Note After Close of the Ordinary Council Meeting

After the meeting the Mayor advised that she had also met with Minister Toole on one occasion.

There being no further business the meeting concluded at 8.40 pm.

Residents support Fit for the Future fight

Woollahra residents have delivered their verdict on the subject of amalgamation, expressing a clear preference that Woollahra Council remains stand-alone in an independent telephone survey commissioned by the council.

The survey was conducted as part of the development of Woollahra Council's *Fit for the Future* submission to the State Government, along with an online survey on Council's website which has so far returned very similar results.

An overwhelming 91% of residents that took part in the telephone survey expressed that 'local identity' and 'local representation' was important to them, and 81% said they support Woollahra Council standing alone. In addition, 80% said that they supported Council's opposition to forced amalgamation.

"Our residents have told us very clearly that they want us to fight to retain Woollahra's independence and to resist any move towards the forced amalgamation of our council and that is what we will do," said Woollahra Mayor, Councillor Toni Zeltzer.

"If Woollahra is forced to amalgamate our residents can expect to pay from \$70 million to \$170 million in additional rates over the next decade, with these increases reflected directly by equally large rate decreases in Randwick. In return for this huge increase in rates, Woollahra residents will receive greatly reduced Councillor representation and no guarantee that the money raised in Woollahra will be invested in their local area."

"I have written to Randwick and Waverley Councils and made it clear Woollahra has no interest in entering into an amalgamation with them, as proposed recently by Randwick Council. Our community has told us that they are strongly opposed to amalgamation and I and my fellow Councillors voted unanimously to defend Woollahra's strong case for standing alone," said the Mayor.

Woollahra Council has been asked to consider entering into a voluntary amalgamation with neighbouring councils as part of the State Government's Local Government reform program, or justify how it will be more *Fit for the Future* by standing alone.

Under the main model put forward by the State Government Woollahra Council would become part of a 'Global City' along with the City of Sydney, Botany Bay, Randwick and Waverley Councils. Such a mega council would have an estimated population of more than half a million people. A merger between Woollahra, Randwick and Waverley would result in a population of 270,000. Council has been independently assessed as achieving all seven (7) of the benchmarks set by the State Government as measures of council sustainability and efficiency. Modelling indicates it would in fact be less efficient if it merged with its neighbours.

"The *Fit for the Future* program promotes the idea that bigger councils are better, and that size equals capacity, however we do not agree with that assessment," said Councillor Zeltzer.

"There is no research anywhere to support the 'bigger is better' argument, while strong evidence does exist to debunk claims that size equals capacity and efficiency. Across the Sydney metropolitan area it is the larger councils that have the weaker report cards in financial sustainability when compared to the smaller, well-run councils like Woollahra."

"Our community is telling us that the Woollahra Municipality is already the right size. This view is supported by the NSW Treasury and Council's own evidence, and we will be presenting a strong case for remaining independent," said the Mayor.

The online survey on amalgamation is still open at Council's website (<u>www.woollahra.nsw.gov.au</u>) and Woollahra residents are urged to have their say. Council's formal response to the State Government on *Fit for the Future* is due by June 30.

Letter to the Editor of the Wentworth Courier - 19 May 2015

Last week, via the media, Randwick Mayor, Councillor Ted Seng called for a merger between his council, Woollahra and Waverley. Given that any such merger would result in huge rate increases for Woollahra residents, and equally large rate decreases for Randwick residents, our answer is no thank you.

Our residents have made it perfectly clear that their preference is for Woollahra to remain a strong, stand-alone Council, and as elected representatives of our community, my fellow Councillors and I will continue to fight for our residents' right to strong local representation.

One of the key factors behind Randwick's support for amalgamation is the claim of large cost savings, however the same savings that will benefit Randwick and Waverley residents would come at a high cost for the people of Woollahra in the form of huge rate hikes.

Randwick's own modelling shows that due to high land values in our area, Woollahra ratepayers would face rate increases of between 22% and 53% if the proposed amalgamation was to proceed. This equates to between \$70 million and up to \$170 million out of the pockets of Woollahra ratepayers over the next 10 years, if Randwick and Waverley rating structures were applied. These increases will fund equivalent rate decreases for residents in Randwick.

In return for this huge financial hit, Woollahra ratepayers would receive greatly reduced Councillor representation and no guarantee that their rate increases will be reinvested in their local area.

Woollahra Council supports sensible local government reform but this should not include amalgamation because NSW Treasury has determined that we are financially strong, now and in the future and that we meet all of the sustainability tests for standing alone.

Recently we commissioned a second, independent survey on the subject of amalgamation and local residents made it very clear they strongly support Council remaining independent. An overwhelming 91% of residents expressed that 'local identity' and 'local representation' was of importance to them, and 81% said they support Woollahra Council standing alone.

I can see how a merger between Randwick and Waverley could work and we wish our neighbours well, should they choose to take that path. However our community has delivered us a strong message that they wish to remain independent. We have listened to that message and we will fight any attempts to force change upon us, simply for the sake of change.

A message from the Mayor



Despite continued community opposition to amalgamation and our strong financial position as a stable, stand-alone council, the State Government has asked Woollahra Council to consider amalgamation as part of its Local Government Reform program

Following recommendations made by an Independent Local Government Review Panel to the State Government, Woollahra Council has been asked to consider a voluntary 'global city' amalgamation with the City of Sydney, Botany Bay, Waverley and Randwick Councils.

The 'global city' merger would result in a huge population increase. from 58,000 to 505,000 [and up to 570,000 by 2031]. The State Government's Fit for the Future program promotes the idea that bigger councils are better, and that increased size equals long-term sustainability and improved service delivery.

The Government is offering a financial incentive to each newly amalgamated council. This one-off payment is minor compared to the long-term financial impacts of amalgamation on Woollahra ratepayers.

The facts on amaigamation for Woollahra are

- Through our community surveys we know that residents strongly favour Woollahra
 remaining a stand-alone council
- Woollahra Council has been independently assessed as being financially sustainable into the future
- There are no demonstrated benefits for Woolahra residents and no guarantee of better service provision through amalgamation
- . There will be a marked reduction in the level of local representation
- · Local residential rates will rise significantly due to higher land values in our area

Woollahra Council's opposition to amalgamation is based on:

- · Your community feedback
- Endorsement of our long-term financial sustainability by NSW Treasury Corporation (TCorp)
- Future modelling which indicates that there will be significant rate rises for Woollahra residents under amagamation
- · No substantive benefits for our ratepayers directly attributable to amalgamation

In March this year, 81% of local residents surveyed opposed an amalgamation. There was an overwhelming preference for Woollahra Council to remain independent, with 91% of respondents placing a top priority on local representation.

The Local Government Review Panel itself has stated that it accepts that: "there is no simple relationship between council size and efficiency and hence no guarantee that amalgamations will produce the benefits sought, especially cost savings." ¹ With the huge costs associated with amalgamation, the unnecessary

With the huge costs associated with amalgamation, the unnecessary disruption and no guarantee of efficiencies or cost savings, Woollahra Council cannot support the Government's view that bigger is better.

The feedback we have received from the community will help shape our Fit for the Future submission to the State Government, due by 30 June 2015.



Councils determined to be Fit for the Future will be given:

- · Access to a State borrowing facility to help fund local infrastructure
- More flexibility with procurement and simplified reporting
- Access to a streamlined IPART process for setting rates; and
- Eligibility for additional planning powers





A MESSAGE FROM THE MAYOR

Despite continued community opposition to amalgamation and our strong financial position as a stable, stand-alone council, the State Government has asked Woollahra Council to consider amalgamation as part of its Local Government Reform program.

Following recommendations made by an *Independent Local Government Review Panel* to the State Government, Woollahra Council has been asked to consider a voluntary 'global city' amalgamation with the City of Sydney, Botany Bay, Waverley and Randwick Councils.

The 'global city' merger would result in a huge population increase, from 58,000 to 505,000 [and up to 670,000 by 2031]. The State Government's *Fit for the Future* program promotes the idea that bigger councils are better, and that increased size equals long-term sustainability and improved service delivery.

The Government is offering a financial incentive to each newly amalgamated council. This one-off payment is minor compared to the long-term financial impacts of amalgamation on Woollahra ratepayers.

The facts on amalgamation for Woollahra are:

- Through our previous survey we know that residents strongly favour Woollahra remaining a stand-alone council
- Woollahra Council has been independently assessed as being financially sustainable into the future
- There are no demonstrated benefits for Woollahra residents and no guarantee of better service provision through amalgamation

Council surveys residents on proposed amalgamation options

Woollahra Council rates could rise between 22% and 53% if the Council amalgamates with its neighbours, as a consequence of the State Government's *Fit for the Future* Local Government Reform program.

Independent modelling indicates that many Woollahra ratepayers face rate increases between \$1,000 and \$10,000 per annum if an amalgamation with Randwick and Waverley Councils was to precede, due to high land value differences between the municipalities. Over 5,500 ratepayers would be affected by increases of this magnitude, with no guarantee of improved services, or additional services.

The State Government's Local Government Reform Program is asking Woollahra Council to consider entering into a voluntary amalgamation with neighbouring councils.

That amalgamation could take the form of a 'global city' merger with the City of Sydney, Botany Bay, Waverley and Randwick councils, or one of a number of other amalgamation options with nearby Councils.

"The *Fit for the Future* program promotes the idea that bigger councils are better, and that size equals capacity, however we do not agree with that assessment," said Woollahra Mayor, Councillor Toni Zeltzer.

"Council supports local government reform that strengthens our community and assures it is financially sustainable well into the future, but in our case we believe this can be achieved without the need to amalgamate."

"Our council already meets five (5) of the State Government's seven (7) *Fit for the Future* financial benchmarks and will achieve the remaining two (2) benchmarks by 2018, two years ahead of the 2020 target date. This strongly supports our case to remain independent," said the Mayor.

"Woollahra Council has been independently assessed as financially sustainable on three (3) occasions by NSW Treasury (TCorp). Additionally, there is no evidence that amalgamation will deliver improved services or result in any demonstrated benefits for our residents. Any amalgamation will reduce the level of local representation and we know that local rates will rise substantially," the Mayor concluded.



The Council has been in existence for 150 years and residents have made it clear that local identity is extremely important to them. Woollahra has the demonstrated capacity to remain a stand-alone council. This position has been supported by residents, who have previously indicated their overwhelming preference for Woollahra remaining independent in a 2013 survey.

Council again wants to know how its residents feel about the State Government merger proposals. It is seeking feedback as it prepares its response to the *Fit for the Future* program, due by June 30.

We will be writing to the community in relation to the amalgamation proposals, and calling on people to share their views via an online survey.

A telephone survey of randomly selected residents will also be conducted on Woollahra Council's behalf this month (March) by Micromex Research.

No fit here for a local council amalgamation

The NSW Government's *Fit for the Future* package for local government reform is not a good fit for Woollahra residents and reads like a forced move to bigger councils. Under the proposal all Councils are required to meet criteria; consistent with the Independent Local Government Review Panel's recommendations, which for Woollahra is e population of around 670 000 by 2031.Woollahra Council has a population of around 57,000 residents.

I do not support the view that bigger is better or smarter, and one size fits all. The *Fit for the Future* package seems to offer no options for smaller, efficient and sustainable councils like ours to continue to exist. The only voluntary aspect of the reform appears to ba choosing which neighbouring councils to join.

A Woollahra Council community survey conducted in mid-2013 indicated that more than 80% of residents opposed a 'global city' merger and supported Woollahra retaining its independence.

The Fit for the Future package suggests more consultation with residents on the issue, which we will carry out, however I am confident that the position of our constituents will not have changed since our last survey and most Councillors have already reinforced that same position to me. In the event of a forced merger with neighbouring councils, our residents would see an increase in their rates of up to 22% because of high land values, with no guarantee of the rates being spent locally and no guarantee

of increased service provision. Woollahra Council has received a positive financial sustainability outlook rating from NSW Treasury and we already partner with neighbouring

Introduction:

I have prepared this Mayoral Minute for two (2) reasons. The first is to enable the Council to lodge its submission to the NSW State Government in response to the Local Government Review Panel's final paper in relation to reform of local government.

The second reason is to inform our community of the Council's current position with particular reference to matters that may directly impact them and affect the Council if all the Review Panel's preferred options are adopted. I have incorporated extracts from our submission to highlight these matters.

Woollahra Council has made three previous submissions in response to the Local Government Review Panel's earlier papers:

- Strengthening Your Community Consultation Paper (June 2013)
- The Case for Sustainable Change Discussion Paper (March 2013)
- Future Directions for Local Government Options Paper (June 2013)

The Local Government Review Panel presented their final paper – *Revitalising Local Government* to the NSW State Government on 25 October 2013, with the State Government in turn releasing the report for public consultation on 8 January 2013. In doing so, the State Government has not provided any response to the report's recommendations but has stated that the Government wants to get on with reform.

A copy of the Panel's Final Report has previously been provided to Councillors and is available on the Division of Local Government's website at www.dlg.nsw.gov.au.

I now welcome this opportunity to provide feedback directly to the State Government on the Panel's recommendations which we hope will lead to constructive and positive reform of local government aimed at increasing the capacity of individual councils and strengthening collaborative relationships between state and local government.

The deadline for the lodgement of written submissions was initially set as 7 March 2014 but has been extended to Friday 4 April 2014.

Council's position on local government reform in NSW has remained consistent throughout the period of the Local Government Review Panel's work. Woollahra Council supports reform that seeks to strengthen local government but it will not support a recommendation for amalgamation in the absence of a clear business case or strong evidence that presents demonstrable benefits to the Woollahra community that cannot otherwise be provided through us remaining a stand-alone council.

Overview of the Panel's Final Report

The Panel's Final Report contains 65 recommendations across the following 12 key themes:

- 1. Fiscal Responsibility
- 2. Strengthening the Revenue Base
- 3. Meeting infrastructure needs
- 4. Improvement, Productivity and Accountability
- 5. Political Leadership and Good Governance
- 6. Advance Structural Reform
- 7. Regional Joint Organisations
- 8. Rural Councils and Community Boards
- 9. Metropolitan Sydney, Hunter and Central Coast
- 10. Non-Metropolitan Regions
- 11. The Far West
- 12. State-Local Government Relation

Annexure 2 to this report presents the Panel's 65 recommendations along with Council's response to the recommendation where applicable. In this regard we have not provided comments in response to recommendations that are not applicable. In preparing this submission, the General Manager, Director Corporate Services and I have been working closely with the Sydney Metropolitan Mayors and SSROC and I have attended meetings with Local Government NSW to assist them in framing their submission.

Executive Summary of Council's Submission

Woollahra Council has presented a very clear and consistent message throughout the period of the Local Government Reform Panel's work. That message is that this Council supports reform, but it cannot and will not support a proposal for the amalgamation of Woollahra Council in the absence of clear evidence of benefits to the community that cannot be delivered under a sensible program of reform. Merger and amalgamation is not considered an essential ingredient to meaningful reform.

Having restated that message, I can also say that the Panel is to be commended for the work they have done, and that this final report does indeed contain many recommendations for sensible reform that I am sure will lead to more sustainable councils and a much stronger local government sector if those recommendations are implemented in a genuine spirit of cooperation between councils and the NSW state government. Some of those recommendations for sensible reform are:

- Promote the establishment of a Metropolitan Council of Mayors.
- Introduce new arrangements for collaborative, whole-of-government strategic planning at a regional level.
- Amend the NSW State Constitution to strengthen recognition of elected local government.
- Adopt a uniform core set of performance indicators for councils, linked to Integrated Planning & Reporting requirements, and ensure ongoing performance monitoring is adequately resourced.
- Maintain the Local Infrastructure Renewal Scheme for at least 5 years, with a focus on councils facing the most severe infrastructure problems.
- Factor the need for infrastructure backlogs into any future rate-pegging or local government cost index.
- Encourage councils to make use of fees and charges and remove restrictions on fees for statutory approvals and inspections, subject to monitoring and benchmarking by IPART.
- Establish a state borrowing facility to encourage local government to make increased use of debt where appropriate by reducing the level of interest rates paid by councils and providing low-cost financial and treasury management advisory services.
- Commission IPART to undertake a further review of the rating system focussed on options to reduce or remove excessive exemptions and concessions, and on more equitable rating of apartments and multi-unit dwellings, including giving councils the option of rating residential properties on capital improved value, with a view to raising additional revenue where affordable.
- Either replace rate-pegging with a new system of 'rate benchmarking' or streamline existing arrangements to remove unwarranted complexity, costs, and constraints to sound financial management.

However, it is extremely disappointing that the Panel have chosen to ignore the views of this Council and our community in relation to maintaining our independence as a council and stick to their preferred position for the widespread amalgamation of councils, and in particular, significant amalgamations in the Sydney metropolitan area. Those recommendations include the proposed amalgamation of Woollahra Council with the City of Sydney, Botany Bay, Randwick and Waverley Councils. No business cases have been presented to support this. Financial sustainability and community representation has been diminished for local government generally in importance in return for an undefined and untested concept of strategic capacity. The Panel, in fact, agrees there is no guarantee of cost savings in any such merger.

As we have outlined in previous submissions to the Panel, and as we are now highlighting directly to the NSW State Government in this latest submission, there is no evidence whatsoever that demonstrates any benefits to our community under the amalgamation proposal.

Our submission presents evidence that ratepayers in this community will indeed be disadvantaged under the proposed amalgamation due to the disproportionately high land values that exist in this part of Sydney's eastern suburbs. The consequential negative impact those comparatively high land values have on Woollahra ratepayers under a merged rating base between Woollahra, Waverley and Randwick Council are significant and cannot be ignored in the amalgamation debate.

Modelling undertaken of the combined rating bases of Woollahra, Waverley and Randwick Councils demonstrates that under existing rating legislation, Woollahra residents would face rate increases in the order of 22% with the revenue used to subsidise service provision in Waverley and Randwick and to fund a decrease in rates for ratepayers in Randwick. We would not expect the adverse impact on Woollahra ratepayers to improve if the rating bases of the City of Sydney and Botany Bay Council were added to the mix. The reason for this is the disproportionately high land values within this municipality compared to our neighbouring councils.

Rating legislation does not permit increases of this proportion to be quarantined to the area in which they are raised. Inevitably, funds will be expended in areas of greatest need within a merged area. Given this Council's already "positive" rating by TCorp it is not unreasonable to assume our ratepayers will incur substantial rate increases but gain no benefit from these increases because the funds are likely to cross subsidise services in other areas.

Evidence provided in our previous submissions to the Panel which supported Council's 'Case to Remain' a stand-alone council included the results of an independently conducted and statistically valid random survey of residents by Micromex Research in June/July 2013. The survey concluded as follows:

- 84% of respondents attributed a positive rating to the importance of Woollahra retaining its independence and continuing to have, a local connection and representation.
- 81% of respondents support Woollahra Council in opposing the 'Global City' amalgamation proposal.
- 75% of respondents are either not very supportive or not at all supportive of Woollahra Council being amalgamated into a 'Global City' Council in the absence of a business case that clearly demonstrates benefits for Woollahra residents.
- In removing the 'fence-sitters' (those somewhat supportive) the data shows that the community is 4.7:1 against amalgamation.

It was also striking in the results from this survey that when presented with a range of 'forced' amalgamation options, more than one third of respondents opted to continue to oppose any amalgamation – albeit forced amalgamation. Further, only 28% would have supported an amalgamation with Waverley, only 22% would support amalgamation with Waverley, Randwick and Botany Bay, and 10% would support amalgamation with just Sydney City. The least popular response was only 5% supporting the Global City concept.

The Eastern Suburbs of Sydney is not an area that warrants state government intervention. Councils in this region are sustainable and through sensible strategic and financial planning, supported by the proposed reforms that look to strengthen the revenue base for councils, councils in our region will continue to improve.

Woollahra Council has already presented TCorp with an updated long term financial plan that sees us move from our 'moderate' and 'neutral' rating to 'sound' and 'positive'. As such, we will continue to advocate for our independence as a council and strive to fully implement the strategies articulated in our Community Strategic Plan which our revised long term financial plan clearly demonstrates we are more than capable of achieving.

The Panel's 'idea' for a Global City Council is an untried and untested concept that is not supported in any way whatsoever by a sound and rigorous business case. It is simply that – an idea – promoted by the Panel as a vehicle that purports to improve the 'strategic capacity' of local government to work more collaboratively with the state government, particularly on matters of regional significance and strategic planning. However, there is no guarantee that the Panel's vision in this regard will be achieved.

Local Government boundaries in the eastern suburbs of Sydney are clearly not a determining factor for Sydney's recognition as a 'truly global city' – Sydney already is a truly global city - based on the following general characteristics which do not include geographical boundaries:

- Home to major stock exchanges and indexes
- Influential in international political affairs
- Home to world-renowned cultural institutions
- Service a major media hub
- Large mass transit networks
- Home to a large international airport
- Having a prominent skyline
- World class hospitals and universities exist.

Similarly, the provision of local services to local communities is not a characteristic of a global city. The provision of local services to local communities is the key functional role of local government. This is what keeps the 'local' in local government.

There are significant consequences of our merger into an Eastern Suburbs Council which cannot and will not be ignored by Woollahra Council in the amalgamation debate. Huge increases in council rates, the subsidisation of services across Woollahra's borders, and the provision of rate cuts for our neighbouring ratepayers is a most disturbing proposition for our residents and ratepayers. This council will not be complicit in allowing that to happen. We will not compromise our identity, our service standards to our community, nor our independent financial sustainability for the benefit of our neighbouring councils.

Endorsement of the Council's Submission to the NSW State Government is strongly recommended.

Sydney Metropolitan Mayors Support No Forced Amalgamations

The Association of Sydney Metropolitan Mayors (SMM) has considered the final report of the Independent Local Government Review Panel - *Revitalising Local Government*.

Chairman of the SMM and Mayor of the City of Canterbury, Brian Robson, said "the SMM strongly supports the NSW Government's position of no forced amalgamations and urges the Government to continue the reform process to strengthen and support our sector. We welcome the opportunity to work closely with the State Government to build a strong local government sector that is better able to deliver a stronger and more prosperous NSW."

In specific response to the Final Report, the SMM notes the following positive reform proposals:-

- 1. Improvements to local government representation, coordination and collaboration between the State and Local Government
 - a. Support the Metropolitan Council of Mayors;
 - b. Establish a State-local Partnership Committee for Sydney and Parramatta;
 - c. Amend the NSW State Constitution to recognise Local Government
 - d. Improve representation of Local Government inside the NSW Government
- 2. Opportunities to strengthen the revenue base of councils -
 - Replacement of rate-pegging (which has led to foregone revenue) by either:
 - i. Rate-benchmarking (set by IPART)
 - ii. Streamlined rate-pegging (increased flexibility for rises)
 - iii. Earned Exemptions for Councils with high financial performance
 - b. Establish a State-borrowing facility to enable Councils to borrow funds at the same rate as the NSW Government saving approximately 2%
 - c. Commission IPART to undertake a review of the rating system, focussing on:
 - i. Reducing / removing exemptions for Council rates
 - ii. Introducing a more equitable rate for apartments
 - d. Recommendations to improve the financial management of Councils
- 3. Opportunities to expand the responsibilities of Councils and to enable better resourced Councils to take on greater responsibilities, where these can be accompanied by a secure revenue stream. Examples are full partnership responsibilities in sub-regional transport strategies, cycleways and major infrastructure projects.
- 4. Improvements to Council governance including clarification of the roles of mayors, councillors and general managers. Support for popularly elected mayors and minimum terms of two years for those who are council-elected.

Members of the Sydney Metropolitan Mayors are of the view that if the NSW Government commits to these positive reforms, widespread amalgamations of councils in SNW may not be necessary and councils will be well placed to deliver a stronger and more prosperous NSW, in partnership with the State Government.

.

The Sydney Metropolitan Mayors comprise twenty two of the thirty eight Councils in the Sydney Metropolitan area and represent more than two million residents. The creation of this group is a recommendation of the Panel's report - a recommendation which had been immediately acted upon in early 2013 by Sydney Metropolitan Councils as a means to provide a voice for our region. We look forward to working collaboratively with the State and Federal Governments in high level consultations to represent both local government and our local communities, as outlined in the report.

- D. Note the results of the recent community survey of Woollahra residents that indicates:
 - i. 81% of respondents support Council's position of opposing the global city amalgamation
 - ii. 84% of respondents attributed a positive rating to the importance of Woollahra retaining its independence and continuing to have a local connection and representation
- E. Continue to oppose the Local Government Review Panel's proposal for the amalgamation of Woollahra Council in the strongest possible terms on the basis that it does not have community support or present evidence of any direct or indirect benefits to residents.
- F. Write to the Premier, the Hon Barry O'Farrell, the Minister for Local Government, the Hon. Don Page, and the Chair of the Local Government Review Panel, Prof Graham Sansom, drawing their attention to the strong community opposition to the Review Panel's proposal for the amalgamation of Woollahra Council into a 'global city.'

Council's Submission:

At the Council meeting held on 27 May 2013, I tabled a Mayoral Minute in relation to the Local Government Review Panel's "*Future Directions for NSW Local Government – Twenty Essential Steps*" paper. The purpose of that Minute was to outlined what I saw as being the structure of Council's submission in response to the Review Panel's latest consultation paper, which as you are well aware, proposed the amalgamation of Woollahra Council into a 'global city' council with the City of Sydney, Waverley, Randwick and Botany Bay Councils, and potentially the Councils of Leichhardt and Marrickville.

As my previous Mayoral Minute made very clear, this Council cannot and will not support the 'global city' idea because we haven't seen or heard any benefits for our local residents from amalgamation that could not otherwise be achieved through minor sensible reform and continuous improvement. The 'global city' proposal is simply an idea - a philosophical position of the Panel than is not supported by evidence of any benefits to the community.

This is the very strong position we have put forward to the Panel in the first section of our submission.

Having stated that, there is much more to the Panel's *Future Directions* paper than the proposed widespread amalgamation of councils. Many of the other options for sensible reform discussed in the paper do warrant support - or at the very least, further investigation. Some of these sensible reform options are:

- Develop a standard set of sustainability benchmarks for councils
- Require all councils to appoint a qualified Chief Financial Officer
- Strengthen the guidelines for councils' 4-year Delivery Programs
- Improve the rating system and streamline rate-pegging to enable councils to generate essential additional revenue
- Progressively re-distribute grant funding to provide greater assistance to rural-remote councils with limited rating potential
- Establish a State-wide Local Government Finance Agency to bring down interest costs and assist councils make better use of borrowings
- Maintain the Local Infrastructure Renewal Scheme (LIRS) for at least 5 years, with a focus on councils facing the most severe problems
- Create a Strategic Projects Fund for roads and bridges to help reduce the infrastructure backlog.

The second section of Council's submission provides feedback to the Panel in response to all of their *Twenty Essential Steps*.

The final section of the submission presents the case for Woollahra Council to continue to exist as a high functioning and strong local government authority that is very well equipped and positioned to provide efficient and effective services to its local community well into the future. This 'case to remain' is presented as an assessment of Woollahra Council's capacity against the Local Government Review Panel's Signposts and Elements of an Effective System of Local Government' as presented in the Panel's previous consultation paper, "*Better, Stronger Local Government – The Case for Sustainable Change*".

Woollahra Council passes each of these tests and so should not be targeted as a problem council warranting state government intervention, let alone amalgamation into a global city.

A copy of Council's submission forwarded to the Local Government Review Panel on 28 June 2013 is provided as **Annexure 1** to this Mayoral Minute.

I have also provided as **Annexure 2** a copy of a Message from the Mayor, delivered to all households in the Woollahra Municipality, in which I outline Council's reasons for rejecting the 'global city' idea.

Community Survey:

Of primary importance in all of this current debate about the future of Local Government in NSW and the prospect of a 'global city' council for Sydney, is what is best for local communities and to what degree do communities value local connection and representation.

To answer these questions, we have asked our community directly by way of a statistically valid random survey of 400 residents conducted towards the end of June 2013 by specialist research company Micromex Research - and the answer is very clear - Woollahra residents do not want amalgamation.

Specific results from the survey include:

- 81% of respondents support Council's position of opposing the global city amalgamation, and;
- 84% of respondents attributed a positive rating to the importance of Woollahra retaining its independence and continuing to have a local connection and representation.
- After adjusting for the 'fence-sitters', 75% of respondents were not very supportive / not at all supportive of the global city amalgamation versus 16% who are supportive.
- This is a ratio of 4.7:1 against amalgamation.

The following statements are some of the direct feedback we received from the survey on the question of amalgamation:

- *Management of the LGA needs to be locally based so it best meets the needs of the community*
- The areas proposed are far too big for Council to be able to manage effectively
- Some of these councils are economically strong and others are weak. As Woollahra is strong, other Councils will rely on that economic base to support themselves
- Council is effectively run as is and increasing the size would only decrease the quality in services and facilities
- Too big a Council will result in a loss of personal connection that I feel I have with Woollahra Council
- Demographics and geography of these areas are vastly different and would not mesh well
- Global City Council would not have the specific interests of Woollahra residents in mind.

Even those who indicated some level of support for amalgamation expressed reservations about the proposal. Direct feedback included the following statements:

- The connection between local residents and Council would be lost, but there could be cost savings for the Council which could strengthen services
- I don't feel I have enough information for me to make a qualified decision, however. I feel there would be an inequality in rates charged
- Amalgamation is needed to create a more economic efficient Council, but this geographical area is too large

- I would need to see what the benefits are for local residents, pros and cons, etc. before making an informed decision
- I need more information, such as when it would happen and the specific effects on the community
- It depends on the costs for the community. If rates and prices of services go up, then I am not supportive. If prices go down, then yes I am.

I also know from the results of surveys conducted by Randwick and Botany Councils that residents in those areas are also strongly opposed to amalgamations.

My position from the start of this debate on the future of local government has been to support the State Government's commitment of no forced amalgamations. I have also publicly stated that I support reform but I cannot support a proposal for the amalgamation of Woollahra Council in the absence of clear evidence of benefits to the community that cannot be delivered under a sensible program of reform that sees us retain our independence.

I stated in my previous Mayoral Minute that the lack of evidence in the Panel's latest discussion paper supporting their global city amalgamation proposal should make Woollahra residents quite nervous. According to our recent survey – they are.



81% of the 400 residents surveyed confirmed they are opposed to the Panel's recommendation to create a 'Global City' in a survey commissioned by Woollahra Council and run by Micromex Research.

According to the Mayor of Woollahra, Councillor Andrew Petrie the survey results have confirmed all the public feedback he has received since the idea was announced.

"The vast majority of residents have made it clear that they oppose any kind of amalgamation with neighbouring areas," Councillor Petrie said.

Woollahra residents have strongly voiced their preference for independence and rated local connection and representation as a top priority, with 84% of respondents indicating that keeping Council 'local' was important.

The following comments are an indication of the type of responses received:

"Management of the LGA needs to be locally based so it best meets the needs of the community."

"Too big a Council will result in a loss of personal connection that I feel I have with Woollahra Council."

"Council is effectively run as is, and increasing the size would only decrease the quality in services and facilities."

The Mayor said, "I think a lot of residents are rightfully concerned that a population increase from around 55,000 residents up to 800,000 would threaten the local connection and representation they need to ensure they get good service, and which makes them feel part of a community."

"I believe there is overwhelming support within Council and within the community to strive for improvement and to make sure local government reform is all about the quality of service we are providing. There is no public confidence in an amalgamation that has not been costed and does not bring with it significant local benefits for residents," the Mayor concluded.

The Independent Local Government Review Panel is due to report to the State Government with its final recommendations before the end of the year.



Message from the Mayor



Dear Resident

The Independent Local Government Review Panel has proposed that Woollahra Council be merged with Sydney, Botany Bay, Randwick, Waverley, Leichhardt and Marrickville councils to form a 'global city'. Woollahra Council rejects this idea for the following reasons:

- 1) With a potential population increase from around 57,000 to 800,000, we don't believe local residents will have the level of representation or connection that they expect and deserve. There is a real risk of local priorities being lost or diminished.
- 2) The Panel has failed to present any real benefits for local residents that would result from the 'global city' merger. In fact, there is much evidence to show that "bigger" does not guarantee "better", particularly in efficient functioning councils. No benefits have been identified for our local community that justify this massive upheaval.
- 3) There are no financials provided on whether a 'global city' would either cost or save ratepayers money.
- 4) The Panel suggests that a large 'global city' council will have much greater 'strategic capacity' to influence the State and Federal Governments on regional matters, without any consequential loss of attention to local priorities. We dispute this idea that strategic influence is more important than locally focussed work and service delivery.

Woollahra Council is sustainable in its own right, as are the other councils. With no evidence of guaranteed benefits and no costs provided, we cannot support a merger. We would much rather see the millions of dollars spent creating a 'global city' directed to improving infrastructure. Our opposition is shared by our fellow councils.

It is important you are aware of Council's position and understand what is being proposed. There are many structural, governance and financial improvements identified by the Panel which we totally support. The creation of a 'global city' however, is not one of them.

The Local Government Review Panel will soon present its recommendations to the State Government and now is the time for local communities to be heard. I encourage you to have your say on the Panel's proposed 'global city' merger before public submissions close on **Friday**, **28 June**. 



The Council note that following the meeting with the Independent Local Government Review Panel on Tuesday 28 May I will be working in consultation with our General Manager and Communications Manager on suitable communication strategies to inform and engage with our local residents in relation to the Panel's proposal for the amalgamation of Woollahra Council with up to seven councils to form a 'global city'.

Background:

The Independent Local Government Review Panel has released its "*Future Directions for NSW Local Government – Twenty Essential Steps*" paper and is inviting submissions in response to the paper until 28 June 2013. The paper presents detailed discussion on what the Panel see as twenty essential steps towards a new sustainable model for Local Government in NSW.

Woollahra Council is preparing a comprehensive submission in response to the Panel's latest paper. This submission will address each of the proposed twenty steps - many of which I believe have considerable merit for reshaping and strengthening the future of local government in NSW but do not require amalgamations to achieve. I will present Council's submission in a future Mayoral Minute.

At this point however, I have to say that as Mayor I cannot support the Panel's proposal for the amalgamation of Woollahra Council with the City of Sydney, Waverley, Randwick and Botany Bay Councils, and potentially the Councils of Leichhardt and Marrickville, as the Panel proposes in Step 15 – Reshape Metropolitan Governance. A 'global city' of this size, as the Panel refers to with a population of between 600,000 to 800,000 people, clearly does not keep the 'local' in Local Government for the residents of Woollahra or the other affected council areas.

As I have stated publicly, this Council cannot support the 'global city' idea because we haven't seen or heard any benefits for our local residents that would not be otherwise achieved through minor sensible reform and continuous improvement. The Panel's paper does not in any way justify the massive upheaval and disruption the implementation of the super-council idea would cause for local residents nor does it present evidence of any benefits to our communities. It is simply an idea, a philosophical position of the Panel than is not supported by evidence of any benefits to the community.

Similarly, there is no evidence that the size of a council determines efficiency or sustainability.

The purpose of this report is to inform the community that we are doing whatever is necessary to protect their interests and to present to the Council what I see as the structure of Council's submission in response to the Panel's Future Directions Paper.

I have also provided copies of Council's previous submissions to the Local Government Review Panel as Annexure to this Minute.

Discussion:

Council's submission should provide comment in response to each of the following twenty steps outlined in the Panel's paper:

- 1. Face the challenges of change
- 2. Create a Sustainable System
- 3. Keep the 'Local' in Local Government
- 4. Confront Financial Realities
- 5. Ensure Fiscal Responsibility
- 6. Bolster the Revenue Base
- 7. Tackle the Infrastructure Backlog
- 8. Promote Innovation, Productivity and Competitiveness
- 9. Advance Improvement and Accountability
- 10. Improve Political Leadership
- 11. Enhance the Status of Mayors
- 12. Revisit Council-Management Relations
- 13. Build Strong Regions
- 14. Reconfigure Rural Councils
- 15. Reshape Metropolitan Governance
- 16. Strengthen the Hunter, Central Coast and Illawarra
- 17. Establish a 'Western Region Authority'
- 18. Progress the State-Local Agreement
- 19. Refocus Local Government NSW
- 20. Drive and Monitor Ongoing Reform

As I previously mentioned, many of these steps, such as ensuring fiscal responsibility, bolstering the revenue base and tackling the infrastructure backlog have considerable merit and are essential elements of a sustainable system of local government in NSW.

Similarly, the concept of establishing a metropolitan Council of Mayors to provide a 'voice' for Sydney and to represent local government and local communities in high-level consultation with State and Federal Governments has merit and warrants further detailed analysis. SSROC has already endorsed this concept in its own submission to the Panel. Our submission will strongly argue however that the massive upheaval that would result from the widespread amalgamation of councils proposed by the Panel, particularly in the Sydney metropolitan area, is unnecessary to achieve what I see as the desired outcome of reform – being the long term sustainability of councils in a high functioning system of local government.

Is reform necessary? Clearly the answer to this is 'yes' as there are many councils struggling to meet the challenges and demands of modern day local government – but many more are not. This has been Woollahra's argument in our two previous submissions to the Panel which have highlighted the many elements of good local government that are working well, not only here at Woollahra, but no doubt similarly well at many councils in NSW.

High functioning councils such as ours need to be encouraged to continue their good work and supported by sensible strategies for reform that enable them to continue to develop and improve performance. Ensuring fiscal responsibility, bolstering the revenue base and tackling the infrastructure backlog are essential first steps in this challenge.

Our submission will argue that the State Government's focus for reform of local government should be directed towards specific intervention strategies for those council areas that are clearly struggling to meet the demands and expectations of local communities. Each of these communities have targeted priorities and different financial capacities to deliver on those priorities. The financial capacity of our community is not in question. We can deliver.

Amalgamations and new models such as the proposed Western Region Authority may well be the answer to problems in specific areas of the State but there is clearly no business case that supports the Panel's view that widespread amalgamation is the only solution to improving the 'system' that is local government.

Other matters that our submission should address include:

> Challenge the Panel's Global City concept

The Panel makes it clear that they see the amalgamation of 5 or 7 metropolitan councils (including Woollahra) as a means of exploring the concept of a "truly 'global city" for Sydney. However, it needs to be highlighted that international literature identifies the characteristics of a true global city – including; business activity; human capital; information exchange; cultural experience; and political engagement.

Some of the general characteristics referred to when talking about global cities include:

- Home to major stock exchanges and indexes
- Influential in international political affairs
- Home to world-renowned cultural institutions
- Service a major media hub
- Large mass transit networks
- Home to a large international airport
- Having a prominent skyline

These characteristic do not include geographical boundaries.

Sydney, in its entirety, is already internationally recognised in the top 10 global cities of the world based on these generally accepted characteristics. Local Government boundaries in the eastern suburbs of Sydney are clearly not a determining factor for Sydney's recognition as a 'truly global city' – Sydney already is a truly global city.

Similarly, the provision of local services to local communities is not a characteristic of a global city. The provision of local services to local communities is the role of local government. This is what keeps the 'local' in local government.

> Reform of Local Government v New Local Government

Our submission will argue that what is proposed through widespread amalgamation of local government in NSW but rather, a drastic attempt to create a higher functioning system of local government in the absence of specific evidence to demonstrate that it will work. Questions we will ask the Panel in our submission about this 'new' model for local government include:

- What are the benefits to local communities of this new Local Government?
- What will be the establishment costs?
- Where is the risk analysis?
- Where is the evidence that it will deliver any tangible benefits?
- Where is the evidence that the benefits will exceed the costs?
- How will the amalgamations be funded more debt, more deficits, more rates?

A properly constructed business case would have answered these questions but the Panel has failed to produce any of these answers.

There are significant risks associated with any major project or reform program and a business case is essential to mitigate associated risks.

The Panel references reform of local government in Auckland as a model – yet a report from the Office of the Auditor-General in New Zealand states that more than \$100 million has been invested in setting up the new Auckland Council's financial, procurement and payroll systems and the associated monitoring and management alone. Using this as a guide across what the Panel proposes for the greater Sydney area could cost Sydney ratepayers hundreds of millions of dollars – and for what benefit? Is it to accomplish 'strategic capacity' or is it to create a structure delivering 'local' benefits to communities funded by local communities?

The hundreds of millions of dollars spent on amalgamations would go a long towards fixing the infrastructure backlog for local communities.

> The Strategic Capacity Argument

The Panel has stated publicly that the proposed reforms, including amalgamations, are not a cost saving exercise. Rather, they state the goal as being to enhance the 'Strategic Capacity' of local government with respect to:

- Coping with complex challenges and unpredictable change
- More robust revenue base
- Scope to undertake new functions/major projects
- Ability to employ wider range of skilled staff
- Knowledge, creativity and innovation

• Credible 'real' partner for State and Federal Government

Again there is no evidence to demonstrate that this goal of enhancing 'strategic capacity' will be achieved at all, or indeed any financial, structural or governance benefits will result – particularly for Woollahra residents and ratepayers.

My strong view on this is that what the Panel is proposing through amalgamation is a significant and unnecessary risk that may not deliver any benefits at all – either strategic or financial. What will be the ultimate cost of this risk and will it pay off?

Our community will not want to take this risk and nor should they. There is a very strong connection between paying rates in return for services but there is little or no evidence to suggest there is a connection between rates and a desire for super cities and the notion of enhanced strategic capacity

Local communities want local services and local connections – they are the things that matter most and this Council is well positioned to continue to provide both of these to our residents very well.

> Woollahra's Capacity

Woollahra Council is well positioned financially to deliver local services –the TCorp report has confirmed this. Financially we are rated as 'Moderate' with a 'Neutral' outlook. While TCorp have said this rating is fine, we want to improve on this and our long term financial modelling is 'hard evidence' that we can do better. This is more evidence than is presented in the Panel's report about the benefits of amalgamation.

Our aim is to move from 'Moderate and Neutral' to 'Sound' or even 'Strong' and with a 'Positive' outlook and we are already in discussions with TCorp on what we need to do to achieve this. We will consider options in this regard over the coming months, and part of our strategy may be to ask our residents to pay a little more each week to have the benefit of improved services and faster infrastructure renewal. We have asked our community similar questions in the past and the answer has always been yes.

Will amalgamation deliver improved services to Woollahra residents? In the absence of a business case we don't know – but the Panel has already told us that amalgamating Woollahra is their preference. My intention is to ask our community directly what they think and I will present further information on how we might do this to Councillors shortly.

What we do know already from combined rates modelling of Randwick, Waverley and Woollahra Councils is that Woollahra residents will be paying higher rates under amalgamation with no improvement in services. I don't believe this is the best outcome for our community.

Higher rates in Woollahra to fund improved services in Waverley and Randwick - how does the Mayor of Woollahra tell our residents that's a good idea?

Where to from here:

There are two community forums I will be attending with the General Manager this week where I will have the opportunity to participate in discuss on the Panel's report and to debate the topic of amalgamation.

The first of these community forums was hosted by NewsLocal earlier this evening at Sydney Boys' High School. The Global City Community Forum provided Mayors from the City of Sydney, Leichhardt, Marrickville, Randwick, Waverley and Woollahra with the opportunity to speak for a few minutes on our response to the Independent Local Government Review Panel's idea for a global city. It was an interesting debate and whilst and I was unable to stay for all of it I think there will be a lot more community feedback to come. The outcome of this forum was agreement from the councils present to make a combined submission to the Panel. I will circulate that submission when it is available.

The second forum is a meeting with the members of the Review Panel and the Mayors, Councillors, General Managers and Senior staff of the proposed amalgamated 'global city' Councils on Tuesday.

Information gathered from these forums will also inform the structure of our submission.

Following our meeting with the Independent Local Government Review Panel tomorrow I will be working in consultation with our General Manager and Communications Manager on a suitable communication strategy to inform and engage with our local residents on their response to the global city idea.

Conclusion:

The purpose of this Mayoral Minute has been to present details of what I see as the structure of Council's submission in response to the Panel's Future Directions Paper. In particular, the Minute is to inform our community of what must be this Council's response to the proposed amalgamation of Woollahra Council into a 'global city'.

The Independent Local Government Review Panel have failed to present clear evidence of any specific benefits to be achieved from the proposed amalgamations and have provided no details of how much this widespread and drastic approach to reform of local government in NSW will cost. Quite simply, there is no business case to support the amalgamation proposal.

My position from the start of this debate on the future of local government in NSW has been to support the State Government's stated position of no forced amalgamations. Further, I have publicly stated that I support reform but I cannot support a proposal for the amalgamation of Woollahra Council in the absence of clear evidence of benefits to the community that cannot be delivered under us remaining a Council in our own right.

The Panel's latest paper presents no evidence whatsoever to change my mind. In fact, its lack of evidence should make Woollahra residents quite nervous.

Finally, I reiterate comments made in Council's submission to the Panel in March. Just as the state government recognises the need for specific specially honed planning instruments to reflect the strategic visioning for specific areas, the state government should equally recognise the need for specific intervention strategies for individual local areas and councils to ensure the future environmental, social and financial sustainability of those areas.



No evidence that a 'global city' will be good for Woollahra residents



Mayor of Woollahra, Councillor Andrew Petrie said he is pleased that the latest report from the Independent Local Government Review Panel supports the NSW Government's position of no forced amalgamations. According to the Mayor, the report does not provide clear benefits for its 'global city' proposal to merge Botany Bay, Randwick, Waverley and Woollahra Councils with the City of Sydney and potentially Leichhardt and Marrickville Councils, with a population of between 600,000 to 800,000 people.

"We don't support the 'global city' idea because we still haven't seen or heard any benefits for our local residents," the Mayor of Woollahra, Councillor Andrew Petrie said.

"The report does not in any way justify the massive upheaval and disruption its implementation would cause for local residents. There is no evidence that the size of a council determines efficiency or sustainability," the Mayor said.

"T-Corp financial analysis on the sustainability of NSW councils and the Panel's latest report confirm Woollahra Council's sustainability and the overwhelming feedback from our community is that they want the 'local' to stay in local government," he said.


"I can't see the logic in merging already sustainable Councils with non-sustainable councils. I was disappointed that the report did not offer up the suggestion that removing the fees and levies imposed by the State Government to finance state responsibilities may provide councils with greater capacity for improving sustainability, viability and efficiency.

"In Woollahra's case we would be able to allocate the \$2.6M p.a we pay in fees and levies for government services that would benefit our community directly and would further strengthen our sustainability into the future.

"We support the report's suggestion that the infrastructure renewal backlog requires a coordinated and cooperative approach from all levels of government. We also support the principles of good governance and strong leadership and reducing 'red tape'.

"I am optimistic the State Government will take up suggestions outlined in the Panel's report to provide more flexible rating income opportunities for Councils to better provide for their local communities," the Mayor concluded.

With more consultation expected with the Sydney metropolitan areas this month and next, the Panel's final report recommendations will not be presented to the State Government until September.

Although I am writing in a private capacity, I have been a Committee Member of the Rose Bay Resident's Association for 13 years and so I have had many years in dealing with Woollahra Coucil on a wide range of issues on behalf of many residents.

I certainly see many problems in the amalgamation of such a large area, part of which is purely residential, some business and residential and some industrial. One size/design/need does not fit all. How can the needs and requirement of a harbour/ocean suburb be compared with the parts of the City – the areas for high rise compared to the areas where the height is limited to that for the residential area.

The bureaucracy to deal with such a huge area would obviously be large and impersonal whereas we know our Councillors and the Staff.

Poorer Councils will feed off those with greater funds which could make them all worse off.

Loss of the personal touch – over the years as a member of the Association, we have helped neighbours/near neighbours in relation to a particular developments that affects them. We have been to Council on (too many times to possibly count) it has always been where the developer wants something bigger/wider/longer than the RDCP permits. I fail to see how the staff/Councillors in such a large area could be concerned about some of these smaller and yet very important issues. We have had great success simply because we are a well educated sensible group of individuals who care about our residents and our area and I hope are seen to work **WITH** Council. I can only assume that that same input would be lost. I guess you call this a loss of local identity.

There are so many small issues that go on all the time e.g wanting a tree pruned, cleaning the streets. I cannot imagine that the GREAT BIG COUNCIL (SOMEWHERE) is going to have the same interest (more importantly knowledge to properly understand the problem) as the current Councillors/staff have.



Dear Mayor and General Manager,

I have completed your online survey but I would like to make a separate submission in my capacity as the President of the History and Heritage Society representing the view of the Society on the heritage implications of any form of merger with other Councils.

At present all of the four Councils listed as part of proposed 'global city' have Local History Sections of the Council Libraries and all of them have some form of History and/or Heritage Society. Whilst I do know that the latter are very active I am not so aware of the scope or performance of the former, other than our own Local History Centre.

Based on my considerable experience and knowledge of the work of the Librarians in our Centre I am amazed at the extent of their knowledge of the Municipality, particularly relating to heritage and the content of the records for which they are responsible. I spend quite a lot of time in the Centre and have observed people coming in and asking quite obscure questions about a building or an event. The Librarians almost always are able to suggest where the needed information can be found or at least where else it might be found if the Centre does not hold it.

It is this detailed knowledge of the Municipality that I fear may well be lost or at least watered down if the Local History Centre is transformed into a 'Global City History Centre' Indeed, they very name is a denial of anything local!

I also fear that the Local History/Heritage Societies will disappear over time. Residents are particularly interested in the area in which they live - look at the number of resident groups we have in Woollahra - Darling Point, Paddington, Queen Street, Double Bay, Harbourview Park, Rose Bay, Vaucluse and Watsons Bay to name but many. It is difficult to see how these groups would operate with a large centralised 'Local' History Centre.

I acknowledge that there are some excellent centralised establishments that deal with heritage - the State/Mitchell Library, State Archives, the National Library and National Archives. But I doubt that they go down to the detail that each Local History Centre does or would even want to.

I think that is probably enough to demonstrate my concerns about the effect that the proposed amalgamations would have on what is, at present, a very effective means of both providing information to residents on specific questions and promoting interest in local history and heritage.

We have attempted to complete the Micromex Research online survey on council amalgamation but I am not confident that it worked on this occasion and we strongly want the Council and the State to know that we should passionately reject any amalgamation.

We have lived at our current address – which we own – in Hargrave Street, Paddington for more than 40 years, and we should not want to be anywhere else. Our terrace house is small but it is magnificently located within walking distance of the Sydney Opera House, the city, Bondi Beach, churches, concert halls and at least four universities.

We find your Council, Madam, far from perfect. Too many roads and footways are in a shocking state while others are prettied up. Garbage collection seems to be unsupervised and the operators treat it as a game to see who can destroy our bins fastest.

But we know of no fault with the Council that would not be very much worse following amalgamation.

It is logical that the fewer people to be served and the smaller the area in which they are, the better the service can be. This is a universal principle. It is the reason why the world's most desirable locations are federations. It is not just Australia: think of the United States, Canada, Germany... The ongoing centralisation of functions during the 20th century with the Commonwealth assuming more and more involvement in what should be State issues has not improved services except for a vast and ever-growing multitude of public service managers.

We think it is possible that amalgamation could result in cost savings but at a totally unacceptable deterioration in service and responsiveness to local needs. If retaining the Council's individuality will have a cost penalty we are prepared to live with that.

We wish you and your Council early and unequivocal success in this.

We don't want to have a Fit.

Amalgamation of Woollahra Municipality into 'global city'

Before commenting on details of the State Government's abovementioned proposal on amalgamations, I would like to mention two over-riding observations;-

1) "Local Government"

In my opinion 'Local Government' means 'local' which surely relates to matters affecting our properties and surrounding areas. This proposed amalgamation would take away our 'local' rights, as Woollahra Municipality would become and insignificant part of a greater whole, known as a 'global city'.

2) Expensive and unrequired change

Just as the Federal Government is trying to convince the population to become more self-reliant, and to demand less from government, this conceptof amalgamation is being proposed by the State Government. A whole new management infrastructure would be required to operate the amalgamated municipalities. From past experience, it is well known how expensive bureaucracy is.

My personal observations and objections

We came to live in Woollahra Municipality because we liked the area. If it becomes amalgamated, it will obviously have to be managed in the same way for the 'new' areas, which will probably necessitate higher rates and taxes.

Even the natural features, for example Sydney Harbour, the ocean, inland areas, etc. are not homogenous areas, and will have different requirements from each other, necessitating more bureaucracy.

Planning requirements should be 'local' matters, not laid down by outside authorities like the Land and Environment Court.

Welfare requirements will probably be different for the newly acquired municipalities – another factor to be avoided.

All in all, this whole idea seems to be the first steps by the State Government to take control of Local Government (in other words, municipalities).

Conclusion

I stand by my 2013 opposition to a 'global city' amalgamation and support Woollahra remaining a 'stand-alone Council'.

Fortunately no-one took him seriously....until now.

Apparently the NSW State Government is seriously considering dramatic council amalgamations into a few mega councils, effectively turning the inhabitants of local areas into anonymous wards of the State.

This may make administration of and liaison with the Councils easier for the Government, but I'm not sure it has any benefit whatsoever for the local inhabitants, certainly not for those who, like me, reside in the generally very well run and well maintained Woollahra Council area.

On the contrary I can see only significant negatives if Woollahra were forced to merge with its neighbouring councils:

- 1. Potential hefty rate rises of between 22% and 53%.
- 2. Corresponding rate reductions for Randwick residents which would cause unnecessary disparity and inequality within the same council.
- 3. Minimal representation on an amalgamated Council present estimates suggest as few as two councilors from the whole of an area stretching from Vaucluse all the way through to Paddington.
- 4. A loss of identity and diminished voice on local issues.
- 5. Inconvenience of dealing with a faceless mega council seated many kilometers away catering to up to half a million residents.
- 6. Vast majority of Woollahra residents do not want their council to be amalgamated.

Doubtless there will be huge costs involved in administering these mergers and potentially greater costs through the inherent inefficiencies of maintaining much larger organizations and then even more huge costs involved in deamalgamating them again in a few years' time as has already happened in many other parts of Australia.

In fact there is not a single shred of evidence of the success of council amalgamation, neither in terms of better services nor greater cost savings and consequently one can only assume it is nothing other than short sighted hubris that has convinced this Government to pursue such a policy in the face of all the prevailing evidence, not to mention in the face of local resident dissent in what is supposed to be a free and fair democracy.

I heartily encourage you:

- 1. Not to support these council amalgamations
- 2. Not to support what can only be described as unauthorized "bribes" using tax payers money to entice impoverished councils to amalgamate voluntarily
- 3. And most of all, not to support any forced amalgamations.

I am writing to you today as a resident of Double Bay to lend my support to the Woollahra Council No Amalgamation campaign.

I won't go into all the obvious reasons why, regarding rate increases, rate disparities between suburbs, loss of identity and lack of local representation, as I'm sure they'll be amply covered by all the other correspondence you receive and campaign material you see.

What concerns me most, as a lifetime Liberal supporter, is that a Liberal government would force a Liberal Council to amalgamate with its neighbouring councils in direct contrast to the firmly held opinion of its mainly Liberal electorate.

I recognize that it is not your seat, but I'm sure you would agree, as an elected official, that it would have to be one the greatest insults to a party's support network in the history of democracy and given that 80% of Woollahra residents vehemently oppose forced amalgamation, anything but democratic.

Woollahra Council is and has been for many years a very well run municipality. I can see no single advantage to any local resident from amalgamation. I understand the Government's broad policy to attempt to reduce the red tape and cost of bureaucracy, but that cannot be at the expense of the quality of life of its people. Especially when there isn't a shred of evidence from Australia or the world to suggest that Council amalgamation reduces either red tape or costs or improves the quality of life of anyone, except perhaps the Minister for Local Government, although even that remains to be proven. In fact, on the contrary, there are plenty of examples of Councils who have amalgamated, pretty quickly de-amalgamating, precisely because their efficiency and effectiveness decreased whilst their costs increased.

By all means investigate the principle of amalgamation. By all means allow those Councils who for some reason see merit in amalgamating to volunteer to do so. But please do not use tax payers' hard earned cash to offer significant financial inducements, bribes by any other name, to underperforming, poorly managed Councils to entice them to volunteer. And please, under no circumstances, force any Council to amalgamate against the clear wishes of its residents, especially not one as well managed as Woollahra and one with such a majority of your own supporters, not to mention members of other parties, in opposition to amalgamation.
