Over the past 25 years the region has drifted into a perfect storm of unsustainably low property rates in both the old Armidale and Guyra council areas, leading to an inability to maintain our local infrastructure, compounded by a stagnating population. The ever tightening financial position and increasing responsibilities carried by councils across NSW has caused an accumulation of under investment leading to a gradual deterioration of important local assets and infrastructure. We need a viable plan to turn the situation around for the years ahead.

Council is proposing a Special Rate Variation (SRV) to bridge the funding gap; this is required to increase our investment in renewal of community infrastructure and assets as well as to improve our operational service delivery. Council has resolved to seek community input on a proposal to seek a permanent SRV of 50% that will be phased in over three years.

In forming the business panel we are aiming to include a cross section of local business owners. The work of the panels will occur in three meetings of two hours each over a three week timetable to enable reflection and processing of information, and we will be providing lunch.

Meetings will be led by an external facilitator and you will hear presentations about the issues confronting ARC from Council staff. The emphasis of panel meetings will be to hear your feedback and engage in discussion with you to ensure we consider all perspectives. Topics to be covered in council presentations will include:

- Understanding the legislative requirements for the rates restructure and the options for consideration
- The financial issues Council needs to consider in short and long term planning
- Options for the application of a Special Rate Variation and the anticipated community outcomes associated with each option
- Infrastructure and capital works programs and service levels
- Expenditure priorities and community capacity to pay
