INSTRUMENT UNDER SECTION 508(2)

WINGECARRIBEE SHIRE COUNCIL

The Independent Pricing and Regulatory Tribunal (IPART), delegate of the Minister for Local Government, pursuant to the delegation dated 6 September 2010, determines:

- 1. Under section 508(2) of the *Local Government Act 1993* (the Act), that the percentage by which Wingecarribee Shire Council may increase its general income for the year 2012/2013 is 7.09%.
- 2. The percentage increase set out in clause 1 above is subject to the following conditions:
 - I. The council uses the Additional Income for the purposes of funding in part the environmental program of works listed in Appendix A of IPART's determination dated June 2012 of the council's application under section 508(2) of the Act.

Additional Income means:

- a) the additional general income raised in accordance with clause 1 of this instrument, less
- b) the additional general income that would otherwise be available to the council under section 506 of the Act.
- II. The council reports in its annual report for each rating year over the period from 2012/2013 to 2018/2019 on:
 - a) the environmental program of works funded by council in accordance with clause 2(1) of this instrument;
 - b) the outcomes achieved as a result of the special variation; and
 - any significant variations from its financial results as forecast in its Long Term Financial Plan and any corrective action taken or to be taken.
- III. The council reduces its general income for the 2019/2020 rating year by: /
 - a) \$1,014,372 (Initial Reduction Amount); and
 - the cumulative additional income derived for the 2013/2014 to 2018/2019 rating years on the application of:
 - 1) any special variation percentage approved under section 508(2) or 508A of the Act for the council for each rating year during the period 2013/2014 to 2018/2019; and
 - 2) any general variation percentage approved under section 506 of the Act for the council for each rating year during the period 2013/2014 to 2018/2019,

to the Reduction Amount.

Reduction Amount means:

The Initial Reduction Amount as increased by the additional income derived for each previous rating year relating to the Initial Reduction Amount.

[Note: the purpose of this clause is to reduce the council's general income to the amount of general income that the council would have had in the 2019/2020 rating year without this special variation.]

- 3. (a) Subject to clause 3(b) below, this instrument supersedes the instrument issued in Wingecarribee Shire Council on 6 July 2008 under section 508A(1) of the Act (2008 Instrument).
 - (b) Clause 2 of the 2008 Instrument remains in force and is not affected by the issue of this instrument.
