
I stand behind Holroyd City Council in the Hands off Holroyd campaign and I urge the local community to pledge their support as well.



RE: Letter of Support to Holroyd Council – For the Fit for Purpose Submission.

Thank you to Lisa Oldridge, Holroyd Council's Manager of Corporate Strategy & Engagement for taking the time to brief me in relation to the Independent Local Government Panel Report of 2013 and the future of Holroyd Council.

Holroyd Council has a proud history stretching back to 1872 when NSW Governor Sir Hercules Robinson granted the petition to incorporate the Municipality of Prospect and Sherwood.

Maturing over the decades the Municipality was re-named Holroyd in 1927 in honor of the very first Mayor of the Municipality Arthur Holroyd. Today, Holroyd has blossomed into a fine city, home to approximately 100,000 people.

Over the years there have been a number of reports into local government in New South Wales examining a whole range of complex issues relating to this level of government, with the most recent being the Independent Local Government Panel Report of 2013.

While the Panel's report contains a number of salient points to be considered by government, the report itself confirms that there is no silver bullet to solve local government's problems.

Holroyd Council unlike some of it's neighbors is a debt free council and has been so since 2010. Any proposed merger between a debt free council and a debt ladened council would effectively punish those rate payers who live in the debt free council.

Additionally, Holroyd City's 100,000 people ranks it the 17<sup>th</sup> most populous LGA out of the 38 Council areas in the County of Cumberland (Sydney) putting it in the top half of populated councils in Sydney.

Furthermore, amalgamations on their own do not solve structural, cultural or management problems. As a former councilor I know for local government to function effectively it requires good governance and effective processes which Holroyd possesses.

Many Holroyd residents have contacted me via email, letter and over the phone to express their support for Holroyd and the distinct character and history of the district as well as it being a wonderful place to live and bring up a family.

Holroyd is now in it's 142<sup>nd</sup> year since it's foundation and I look forward to seeing it flourish for many more years.

I do not support any forced amalgamation and I support Holroyd Council's continuation as a council in it's own right.
