# 11.2 FIT FOR THE FUTURE - RESPONSE TO IPART

Yass Valley Council along with 60% of 152 Councils across NSW have been declared unfit in IPART Assessment of Council's Fit for the Future Proposals that were submitted at 30 June 2015.

All Councils have until 18 November 2015 to provide a response to IPART findings. Council needs to determine a preferred direction in relation to the response.

### RESOLVED that -

- 1. Council note the findings for Yass Valley of the IPART Assessment of Council Fit for the Future Proposals;
- 2. Council note IPART's comment in the assessment for Yass Valley that as a result of delaying any Special Rate Variation (SRV) "This unexpected change in approach by the council to the key improvement strategy suggests the council may not be able to return to the operating balance of surplus in the required timeframe";
- 3. Yass Valley Council remains as a standalone Council;
- 4. Council provide feedback on the IPART assessment by advising NSW Department of Premier and Cabinet as follows:
  - Yass Valley Council acknowledges that it met all Fit for the Future criteria with the exception of the sustainability criterion which showed a negative operating performance ratio in 2024/25;
  - b) Yass Valley Council should remain a standalone Council in accordance with the recommendation of the Independent Local Government Review Panel in their report released in October 2013;
  - c) Yass Valley Council will apply to IPART in February 2016 for a Special Rate Variation from 2016/17 as identified in its June 2015 Fit for the Future submission, with the objective of ensuring a positive operating performance ratio in 2024/25;
