




## **QUESTIONS/ISSUES RAISED**

Was the cost of maintenance grading in a dry year

- considerably less than the cost of maintenance grading in a wet year?
- Asked for a cost analysis of the difference between the routine maintenance grading cost and the gravel resheeting costs.
- Has consideration been given to the ability of the ratepayers to meet the current rates and the anticipated rate increases in future years?
- Asked for a breakdown of the computer network usage and workings and why there was such a need for such an extensive number of computers and the allocation of capital works monies for the forthcoming ten year long term financial plan?
- Questioned the need to improve the disabled access to the swimming pool as considered there was already suitable access for disabled to enter and leave the pool.
- Referred to walk way construction passing under the Jack Renshaw Bridge (over the Castlereagh River) and the fact that the walk way finished with a set of stairs and thus was not accessible by disabled or other users.
- Questioned the financial reserves required for the extensive number of road works to be completed by the Shire.
- What is the long term outlook with the acknowledged reduction in per capita return in previous years and thus, where was the future headed?
- What is going to happen in four or five years time when the next Council comes in? Will there be a request of a similar sized rate increase?
- What happens to the 10% increase in three years time?
- Who has the right to vary the percentage rates based on land value and farmers pay 72% and raised whether Council should consider reducing the 72% because of the lower level of services required of the rural segment?
