

Attachment B - Submission Report – Special Rate Variation

Bellingen Shire Council received 107 submissions regarding the Special Rate Variation proposal. These submissions were collected through survey responses, emails, letters and website. The open field section of the online survey has been included in this report. The multiple-choice analysis can be viewed in the survey analysis report **Attachment C**.

Of these 107 submissions, two were received after the consultation period concluded on 31 January 2023. It is noted that these submissions have been accepted and considered as part of the engagement process.

The types of submission received were as follows:

- 73 online surveys
- 13 hardcopy surveys
- 19 email submissions
- 2 letters
- 1 general website query

A full list of submissions received have been included below. Personal details have been redacted or removed to protect privacy.

Submission 5	SURVEY - HARDCOPY	<p>BSC rates already very high. I'm aware of unrateable land reasons and others. It's not that long ago that BSC applied the last SRV. More economic measures need to be sought. For example the Street Sweeper is not necessary or effective, a complete waste of money. Also, I don't agree with BSC continuing to promote tourism, as we already have more tourists than facilities and parking etc. to accommodate them.</p>
Submission 6	EMAIL	<p>To the Elected Representatives and Officers of Bellinghen Council</p> <p>Thank you for the opportunity to provide input into your consideration of a Special Rate Variation (SRV). I have tried unsuccessfully to access the Council Website since attending the "Drop In" at Dorrigo on 18 January. I called Council and was advised that an email submission would be an appropriate alternative to responding to the survey.</p> <p>As background, my wife and I are self-funded, semi-retired owners and residents of [REDACTED] on the Dorrigo Plateau.</p> <p>I wish to state my objection to any SRV.</p> <p>I strongly believe the Council has an obligation to manage its costs in a responsible manner. Many businesses and households in the shire would like to spend more money and provide more services, but we are limited to what funds are available. We are all suffering increased costs in many aspects of our lives at present. Councils situation is only different because of its ability to impose legally enforceable charges to its ratepayer "customers".</p> <p>The Council representative I spoke to at the "Drop In" suggested that some ratepayers really only want "roads and rubbish collection". I suppose I am one of the people who would prefer Council provided less services at my expense. You claim that Council provides more than 50 unique services. I pose a serious question as to why?</p> <p>I am a rural resident. We get:</p> <ul style="list-style-type: none">• no sewer;



	<ul style="list-style-type: none">• no water;• no rubbish collection;• no footpath maintenance;• very little road maintenance;• no street lighting;• etc... <p>According to your Flyer seeking support for the SRV, the average rural property rates are roughly 2.22 times that of a residential property...despite access to less services...I understand this is probably not the forum to explore the unfairness of that reality, but it is part of the background for my objection.</p> <p>I also wonder how many ratepayers understand the long term impact of your proposal. It was confirmed by the Council representative I spoke to that the SRV was not proposed to be temporary. That is, at the end of the 4 year period, the SRV will not be reversed, but rather will remain as part of the ongoing rate base for future increases.</p> <p>If the SRV is adopted, 10 years from now you will be asking me to pay close to \$5,000 p.a. in rates rather than \$4,000 I would be paying without the SRV. I imagine I will still get:</p> <ul style="list-style-type: none">• no sewer;• no water;• no rubbish collection;• no footpath maintenance;• very little road maintenance;• no street lighting;• etc... <p>So, I absolutely disagree with any SRV. Rather, I request that Council take a long hard look at what services are actually accessed by ratepayers. Anything that is not broadly utilised across the community should be considered for possible termination or reduction. Council should get back to its role of "Roads and Sanitary Services". When money is tight, as with any responsible household or business, Council must take difficult decisions and non-essentials must go.</p> <p>Continuing to increase ratepayer charges and providing numerous underutilised services is NOT sustainable.</p>

Submission 11	SURVEY – ONLINE	<p>Due to living in Repton and having very limited input from council in our area I don't see why we should be paying more for our rates. Our roads are rarely repaired, the verges are occasionally mown and only along Perrys Rd, we have dogs roaming the neighbourhood with little done by the council ranger. Bellingen Shire has an increase and a large number people who are priced out and unable find suitable affordable housing for their needs and they are forced to live rough or leave the shire due to an ever increasing high cost of living, which seems to rise everyday such as fuel, insurance, food, interest rates, medical fees etc etc. Yes all of the reasons Council has quoted for requiring the special rate increase, however the residents are doing tougher than the council. Decrease wages and over staffing or at least put a freeze on the highly paid staff of council and reduce the waste within before asking the residence to agree to this outrageous increase. Long term, community minded residence are valuable to this shire through their continuous voluntary community contribution and simply are not able to keep up with ever-increasing cost of living as it is without a special rate increase. Submission 18	SURVEY – ONLINE	Mylestom has not received the promised sewage to our town , Bellingen Council had ample time to organise this with budget afforded but now they have left it too late and it can now longer be afforded. Submission 19	SURVEY - HARDCOPY	I am a single parent and we are single income household. My mortgage payments have just gone up by nearly \$300 p/m and the cost of living has risen significantly. In the current economic climate, another rate rise will put even more financial pressure on me, trying to raise my children. I am already working so hard. Please don't.
Submission 20	SURVEY - HARDCOPY	Rather than increasing our rates, I propose that Council increase their efficiency. We cannot afford to increasingly finance the inefficient way this Council is run.
Submission 21	SURVEY - HARDCOPY	- We cannot afford the increase. The DA + CC teams are under resourced. It should not take 12 months to get construction consent/certificate. We are paying 2 x GMs. - The roadworks heading towards the motel had to be redone about 10 times. Similarly the roadwork near the dog kennels took ages. Submission 25	SURVEY – ONLINE	This council's rates are already extortionate. Yes, extortionate. I am already paying more on rates than I am on food. The rates are already not affordable. In the decade I have been here there have been two SRV's already. These are meant to be rare, aren't they? Increasing the fees you charge ratepayers - who are all suffering from the increased cost of living - is not the answer. The rates are not affordable. Enough with the SRV's. There needs to be another way. I realise there has been a lot of cost-shifting from federal and state govs onto local councils and this is part of the, or perhaps the major, reason council keeps running out of money. Perhaps the smart thing to do is to push back. You have an entire community that is pissed off at the prospect of higher rates. Why not harness that to demand a set of changes from the above levels of government? We cannot be the only shire dealing with this issue. I don't know the details of what costs could be pushed back up a level, except for the way state forestry is subsidised to run at a loss and destroys our local roads without paying a cent toward maintenance of these roads and bridges. An SRV is not the answer. Get creative. Harness the ideas in the community. Find other ways. The rates are not affordable now, let alone with any increase.
Submission 26	SURVEY – ONLINE	I would like to know whether council has done anything to reduce their operating costs or to evaluate internal inefficiencies with both processes and staff performance. I believe that this should be a priority before asking rate payers for a rate variation.
Submission 27	SURVEY – ONLINE	The current council campaigned on a promise of lower rates. You now propose much higher rates than the previous council. Why aren't council lobbying the state and federal government for more funds?
Submission 28	SURVEY – ONLINE	It is still not clear to me what financial impact the SRV would have to me and my husband. I used the calculator. I read some great information from councillor Ellie Tree and councillor Jennie Fenton on Facebook. I know the SRV only applies to one area of our rates, but how much will the other areas rise outside of this? I think there is a need for balance between council's financial needs (which I appreciate) and ratepayers financial needs. Committing to a potential 4 years of SRV rate rises is a big ask when lots of people have big mortgages and other responsibilities. It will also have a negative impact on renters, many of whom are already struggling. If it was 1-2 years, I'd be more supportive of this motion but as it stands I have mixed feelings. Would council consider the other financial stressors on ratepayers before implementing the SRV? How would that factor into rate rises? Could council communicate their thoughts on this? I understand this is a difficult situation, and inflation is affecting everyone. I wasn't able to attend any drop-in sessions but I appreciate this opportunity to share some of the thoughts I have. The special rate increase is significantly higher than the basic peg increase and is poorly justified in terms of inflationary pressures on council costs. 2. Pandemic linked supply chain pressures and increased oil prices as a result of the war in Ukraine are the reasons given for this hike. Yet Council is seeking approval for increases four years into the future. This runs counter to the reserve bank's prediction that inflation will ease through 2023 as China emerges from pandemic isolation.



		<p>3. Council staff have used statistics and calculations in misleading ways to suggest that the proposed increase is minor. It is not. It is significant and will impact residents for several years to come. Quoting the increase as a weekly figure when rates are billed annually is to deploy deception of scale.</p> <p>4. Residents already face an accommodation crisis due to an exponential increase in rents and house prices over the past 2 years. This has increased land values in Bellingen, in particular, with rates already rising as a result of higher land values.</p> <p>5. This accommodation crisis is on top of a cost of living crisis that has affected fuel, electricity and food. That council should compound this problem by hiking its rates adds insult to injury.</p> <p>This proposed rate increase is ill timed, unfair and unreasonable.</p> <p>Council should reduce its spending or seek alternative sources of income from state or federal governments and not burden its owner ratepayer base.</p> <p>Regards</p>

Resulting in people on fixed income suffering the burden of bringing down inflation.</p> <p>As an example of how this has affected me personally since moving to Bellinghen 5 years ago we regularly shop at the closest Woolworths being at Sawtell as we found the prices at the local IGA were unsustainable for our personal budget. In that time the price of bread has increased from \$1.60 a loaf to a current price of \$2.20. That is an annual increase of 8%. For the whole of these 5 years I worked [REDACTED] and received the standard award increase of around 2%. Meaning my income has significantly fallen short with keeping up with the cost of bread. I am in the same situation as Council in that my electricity bill has gone up at the same rate as Council's, my maintenance bills have gone up at the same rate as Council's my fuel bill has gone up at the same rate as Council's, my insurance has gone up at the same rate as Council's. But unlike the Council I can't charge my employer more money. Unfortunately, this has resulted in me having to quit my job [REDACTED] and pursue employment elsewhere.</p>

Submission regarding proposed Special Rate Variation.

I would like it noted that I oppose the proposed Increase to Rates above the Rate Peg limit.

While I understand the financial pressures on Council, I do not support the move to continuously expect the Ratepayers to fill the gap that Council is experiencing. Since my time on Council (1999-2008) I have seen both one off and permanent Rate increases due to Council successfully achieving such Rate Variations. The cumulative impact has been to provide a significant financial burden upon Ratepayers, who live in a low socio-economic area, many with incomes or wages failing to increase in line with cost of living expenses.

I would be willing to accept a reduction in the current level of Council services to avoid the proposed Special Rate Variation. For example - closing all Council run Libraries by one or two days per week, would be acceptable.

I would also like to see Council continue

to achieve greater efficiencies in its overall operating costs. One area of considerable concern to many residents and ratepayers is the increased number of Senior Management positions created on Council. I think that Council needs to do its share of 'belt-tightening' to reduce operating costs by reducing the positions of Deputy General Managers. It will be more difficult to remove these new additions to staff, but even if it takes time, it would be a worthwhile goal to pursue. This would help to regain the trust and respect of the community, which I believe has been diminishing ever since these new positions were created.

I understand the significant financial pressure 'cost-shifting' has had on Council, as well as the low rate base due to many State Government agencies which operate and yet cannot be levied rates. These are significant issues of concern that can only be rectified by achieving a better funding share for local government. With the upcoming State election in March, now is the time Councils (and the local government and Shires Association) needs to be publicly lobbying all those standing for this election, to gain commitments to address and change these positions. The Departments that cover Crown lands, State Forests and National Parks should all be required

to pay Rates, as they currently receive income, while paying nothing towards the upkeep of roads, bridges and facilities that come with the thousands of tourists that access their respective areas. This needs to change. When it does change, Council will have a significant improvement in its Rates base and be financially significantly better off. Now is the time to be pro-active, as this opportunity to rectify this blatantly unfair impact on local governments only comes every four years.

Finally, I commend Council making people aware of the Financial Hardship Policy (which I am not sure is [redacted]) I do not wish to see it used as part of the justification for why a special Rate Variation should be allowed.

Thank you for your consideration of these issues, and I look forward to seeing how sincerely Councillors take up the issues I have mentioned, to avoid the need for a SRV.
