 - (c) In accordance with section 97DD of the Act and clause 73J of the Regulations, the Scheme Administrator now amends that accreditation:
 - (1) by accrediting the Sequestration Pool Manager as an abatement certificate provider in relation to the New Carbon Sequestration Activity (in addition to the Existing Carbon Sequestration Activities);
 - (2) on the conditions referred to in clause 3 below,

with effect from the date of this Notice.

3 Accreditation Conditions

- (a) In accordance with section 97DD(1)(b) of the Act and clause 73J of the Regulations, the Scheme Administrator imposes on the Sequestration Pool Manager's Accreditation the conditions set out in this Notice and in:
 - (1) the attached Special Accreditation Conditions; and
 - (2) the attached General Accreditation Conditions.

(b) The Scheme Administrator hereby gives the Sequestration Pool Manager written notice of the conditions referred to in clause 3(a) of this Notice, for the purposes of clause 73J of the Regulations.

4 Pre-Conditions to the creation of NGACs for New Carbon Sequestration Activity

Despite the Sequestration Pool Manager's Accreditation, the Sequestration Pool Manager must not create any NGACs in relation to any New Carbon Sequestration Activity in any Eligible Forest on any New Eligible Land nominated in Item 3(a) of the Schedule until:

- (a) the Sequestration Pool Manager provides the Scheme Administrator with:
 - (1) an undertaking referred to in clause 5 of this Notice in respect of that New Carbon Sequestration Activity; and
 - (2) a Restriction On Use referred to in clause 6 of this Notice for each parcel of that New Eligible Land; and
- (b) the Scheme Administrator notifies the Sequestration Pool Manager in writing that it is satisfied that any other preconditions for the creation of NGACs set out in the attached Special Accreditation Conditions and General Accreditation Conditions have been met.

5 Clause 73HA Undertaking Given by the Sequestration Pool Manager

In accordance with clause 73HA of the Regulations, the Scheme Administrator requires the Sequestration Pool Manager to provide an undertaking that where the Sequestration Pool Manager creates any NGACs for the Accredited Carbon Sequestration Activities, the Sequestration Pool Manager will not use (or allow any other person to use):

- (a) any Carbon Sequestration for which those NGACS were created; or
- (b) any greenhouse gas abated or taken to be abated in connection with that Carbon Sequestration,

for the purposes of complying with another mandatory scheme (whether in New South Wales or in another jurisdiction) intended to promote Carbon Sequestration or the reduction of greenhouse gas emissions.

6 Maintenance of Greenhouse Gas Abatement

The Sequestration Pool Manager must provide the Scheme Administrator with a Restriction On Use for each parcel of Accredited Eligible Land.

7 NGACs to be Created in Accordance with the Law

The Sequestration Pool Manager may only create NGACs for any Accredited Carbon Sequestration Activities in accordance with the Act, the Regulations, the Carbon Sequestration Rule, this Notice, the attached Special Accreditation Conditions and the attached General Accreditation Conditions.
