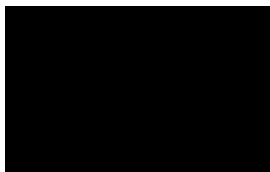
I have approved that Council may make and levy the following minimum rates:

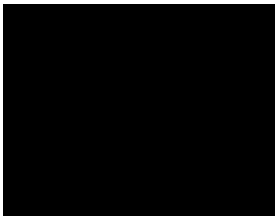
**LOCAL GOVERNMENT ACT 1993**

**INSTRUMENT UNDER SECTION 548(3)(a)**
