



Especially the Town planning departments pro over-development policies and approving non compliant developments that go against the councils own LEP and DCP controls.

Further to my objection to Canterbury Council's SRV, I would like to submit the following additional information in support of my objection.

This information has been taken from the Agenda for the Extraordinary Meeting, dated 4th February 2021.

Council have gone to great lengths to indicate that they have consulted the community at large. I believe this is false and not only have they failed to adequately consult the community but in some cases they have only consulted those that would support the arguments they were trying to make (Refer Aquatic Centre survey below)

Page 19

Provides detailed information on how Council consulted the community. These methods are flawed as they, for the most part, rely on the ratepayer either being aware of the issue in the first instance and then making enquiries or being made aware of the issue when they attend various council facilities in the municipality. Personally, I did not receive a letter; I do not frequent council facilities (i.e. Service centre, library, aquatic centres, art centre etc); I do not receive the newspaper "The Torch" in my area; I did not visit the One Rate Website as I did not know it existed, therefore I did not have access to FAQ's, Hotline, Email etc; I did have access to electronic newsletters and did not have any face-to-face meetings as I was completely oblivious to the proposed SRV.

Council have made these things available without going to sufficient lengths to let people know they are there, which is why the response to them has been so poor.

Council acknowledge they had 234 face-to-face discussions and received 325 telephone calls. According to the 2016 Census, the population of the municipality is 373,931, so face-to-face discussions represented 0.06% of the community and telephone calls represented 0.08%. Hardly an overwhelming response to something that people would be most likely to disagree with than agree with. The One Rate landing page apparently had 2,500 views. It is false to make any assumptions with regards to this number as it is impossible to determine how many of these views can be attributed to people that actually reside in the municipality. These could also represent journalists, people thinking of moving to the municipality or people just curious as to what Council is planning. Given the page was linked to social media posts, it is possible to determine whether the 385 people who were transferred to the One Rate page were from the municipality, but no clarification has been provided.

At the close of the exhibition (which I did not know existed), the Council received 147 submissions. So in summary, Face-to-face was 0.06%; Telephone was 0.08% and Submissions were 0.03%. The Council claim to have sent letters to 114,500 residents, yet the total above responses of 234+325+147=706 or 0.6% of 114,500/0.18% of 373,931. Council is content to have as few respondents as possible.

Page 27

Council refer to a survey of patrons of an aquatic centre, stating 89% of respondents felt the facilities were run-down and need investment to provide the service that they expect and need. Firstly, irrespective of whether or not the respondents are ratepayers of the municipality, the survey should be put to ALL ratepayers, not just the handful that will benefit from the outcome of the survey and are therefore biased in their opinion. It is ALL ratepayers paying for this service, whether they use it or not is irrelevant, so it is all ratepayers that should have been surveyed.

Council are misleading in their use of statistics, failing to indicate the number of people surveyed instead using a percentage in order to give the appearance of overwhelming support removes much needed perspective.

Page 30

By Council's own admission, they know that almost 14% (48,000) of our community are 65 and over, yet this population is not adequately represented in feedback received to Council on the proposal.

"Despite these numbers, at present we only have 328 pensioners (or less than 1% of community over 65) who have taken up the rates deferral." This should not be considered an indication of acceptance of the proposal. Firstly, a large percentage of older people do not have the ability to access the internet and may, in some cases, be house bound and not actively attend Council facilities. There may also be a large percentage who may not have requested a deferral for fear of taking on debt (which is how most elderly people perceive a deferral); fail to understand the deferral process; may encounter language or cognitive barriers etc. Anyway, the 706 responses above represent 1.47% of the 48,000, IF the entire 706 responses were aged over 65, which is unlikely, so consultation with the elderly population has been virtually non-existent.

Page 46

It is stated that "without a SRV to increase total income, there would be:"

- No additional income to keep assets maintained to satisfactory standards;
- No additional income to increase service levels;
- No additional funding to allow the implementation of the Leisure and Aquatic Strategic Plan;
- Significant financial reforms required to adjust our standard of servicing and approach to managing our ongoing liabilities; and
- A continued decline in Council's financial performance and financial indicators set by Government which will raise concerns for our Auditors and our ongoing ability to remain sustainable, particularly our obligations to maintaining all our long term assets. It may be necessary to sell or dispose of other assets.

I for one, would be happy to see Council dispose of assets that are unviable; under-utilised; obsolete or excessively onerous from a financial perspective. It is not good enough to say we are going to keep asking ratepayers for more money to maintain assets that we simply can't afford to hold. If Council were a private company, they would have been bankrupt many years ago.

Page 47

"During the engagement some responses noted that Council should revert back to the core services. This included dropping non-essential services such as community grants, events and

social and community services. It must be noted that these cuts can be undertaken but would unlikely address the required financial shortfall." Yet not only are Council unwilling to consider cutting any of its services, its intending on adding more. Page 44 - \$4m to "provide new and enhanced services"

"If Council was to deliver the necessary savings it would have to review those areas of highest cost in the Council. The list below is a summary of the major direct services provided by Council via the general rates in order of cost (waste is excluded as it is funded separately through the waste charge and operational support is excluded as it is the base support maintaining the operation of the Council):

- 1. Roads
- 2. Parks and Open Space
- 3. Libraries
- 4. Leisure and Aquatics
- 5. Regulation and Compliance
- 6. Flood and Stormwater Management
- 7. Footpath
- 8. Sport and Recreation
- 9. Property Management
- 10. Governance
- 11. Community Services
- 12. Town Centres
- 13. Streetscapes
- 14. Children Services
- 15. Development Services"

Council seem to be of the belief that the community have an expectation that Council provide a multitude of services covering all aspects of our daily lives. I think if you genuinely attempted to speak to the community and provide them with clear options about what services they want and what services they would be prepared to give up in order to ensure both Council and ratepayers can live within their means, you would be surprised that the community may be content to give up many redundant services.

Perhaps Council's tendency to allow infrastructure repairs to lag through the year, followed by a ramping up of repairs towards the end of the financial year so that council can ensure full use of budgeted funds in order to make a case for additional funds in the next financial year, needs to reined in. How about we start trying to ensure we have some money left over at the end of the year. How about we look at staff efficiencies and other staff costs, especially now Canterbury has merged with Bankstown – I have seen absolutely no benefit whatsoever in that amalgamation.

Finally, I would like to express my concerns for the fact I and my neighbours were not represented on the day this proposal went to a vote. My representative, Clr Raffan was absent due to illness and I also understand another Clr, Clr Tuntevski was also absent. It should also be noted that two Clr's objected to the proposed SRV, so had there been two more potential objections the ultimate vote may have been different. It is unacceptable that such an important vote be carried out without proper community consultation and without the presence of all councillor's representing all members of the community.

I do not understand how Council thinks families like ours are expected to afforded the constant grab for cash by Canterbury Council. It never ends. It's the same song every time they want more money - we need it to maintain parks, roads, services etc. I believe there is a serious issue concerning the Council's ability to manage their finances. Has it ever been considered that Council was perhaps not living within its means?

I think this perpetual argument that if residents don't pay more it puts services at risk is disingenuous. It's not good enough to just say services are at risk if we don't pay more. I think it's about time Council give ratepayers the option as to what services they want. I'm paying for swimming pools, parks, libraries, childcare facilities and god only knows what else. I don't benefit from these things so I don't want to be constantly paying for them. Unfortunately, I have no choice but to pay for them, but Council can't continue to treat ratepayers like a bottomless pit of cash. It's about time Council make some of these services, strictly user pays or they go.

If the community is best served with a combination of user pays and ratepayer subsidy for some services, then the Council need to be able to afford it with the money they have, not stick their hand out for more and more every year. Canterbury swimming pool for example, uses a combination of user pays and ratepayer subsidy. If increasing costs cannot be offset by increasing entry costs, then it is not financially viable. The ratepayers should not be constantly on the hook for Councils over indulgence in unviable services.

My rates should also be broken down into categories to show where the money is going, much like the Federal Government do with your tax return (Notice of Assessment). Council go on about needing money for services without specifically saying how much they need and for what. Ratepayers are just told we need to increase rates by x% to cover the cost of maintenance and services.

When the \$250 discount for pensioners was introduced it was meant to cover 50% of a pensioners rates – it's never been increased. \$250 is nothing. I am completely astounded by the recent blatant money grab by Canterbury Bankstown Council for a 36% rate increase over 5 years. It sounds like an ambit claim asking for the sky and accepting somewhere in the middle. In the end the rate payers are the losers.

With the economy staggering from the effects of a pandemic with job losses and businesses in financial stress this should be a time for stability not opportunism.

There is no certainty that these job losses will be replaced. The current RBA interest rates are at record lows and are affecting the retirement prospects of numerous people. Then there has been many years of stagnant wages affecting wage earners. The current growth rate of inflation is around 1.9% so a request for more than a 30% increase over 5 years seems out of touch with the community expectations.

Australia's near-stagnant wage growth has persisted long before the COVID-19 crisis began. data from Deloitte Access Economics showed. Using the wage price index, wage gains were only a little over 2% when COVID hit, and we forecast they'll only return to that relatively sluggish rate by late 2025 or early 2026," analysts said.

In 2019, former Treasury official Chris Richardson – who penned last year's forecast from Deloitte – also predicted Australia would only be "treading water rather than roaring into recovery". 21 Jan 2021)

Given all the expert advice on the economy this seems an inappropriate increase for the Canterbury Bankstown Council to request.

Canterbury Bankstown Council has already implemented an Rate Harmonisation (or equalisation) policy.

The harmonisation will affect every ratepayer and is a requirement of the NSW Government as stated on the Canterbury Bankstown Council Website. Council's number one priority is to ensure every ratepayer gets value for their dollar and that their money is invested in the City. The council has already increased rates with this Harmonisation especially within the Bankstown Council zone.

The reason behind the mergers proposed by the Baird Government was to save ratepayers money over time.

An IPART report, released in October 2015, found local government mergers could save ratepayers money over the next 20 years. (ABC Friday 18 December 2015)

Ms Berejiklian NSW Government said the policy of council mergers was a "sound" one, and residents in areas where councils had been amalgamated had benefited.

With more people building Duplexes and units Council is again receiving increased revenue. This is even before the Council unveils another radical plan for communities .

With IPART showing mergers should save money, amalgamated councils having benefited from their Harmonisation program and increased revenue from developments throughout the area an increase





A cumulative rates increase of 36.34% over 5 years is obscene.

Even a yearly rates increase in excess of CPI or the official RBA interest rates are excessive and obscene. From 2022, the rate increase exceeds 7%. This is double the cost of most home loans, and way beyond what can be earned from a bank savings account.

If indeed Canterbury Bankstown Council were implementing efficiencies, then there would in fact be no reason to increase rates. On the contrary, rates would remain static or even decline if there was greater productivity. At worst, the rates will increase by no more than CPI.

I am writing to you regarding a proposed increase rate rise of 36% over a 5 year period commencing 2022 by Bankstown/Canterbury Council. We understand that IPART currently has an application before IPART for that increase to be granted.

My wife and I have been residents of Padstow (2211) for a period of over 40 years during which time Bankstown Council has been reasonable with its charges and services to residents. We pay \$2000 in residential rates per annum for a 600 metre block .

Since amalgamation by the Baird Government with Canterbury Council, we have witnessed a drastic downturn in Council services. The streetscape does not appear to be cleaned and maintained any longer and we have also noticed the areas in Canterbury to be even worse. We have not had a street cleaner/sweeper in our street for over 12 months. The Council areas are in a far worse condition today than ever before. Roadworks and street maintenance have almost stopped over that period.

One example of Council service and attention to ratepayers is the fact that I wrote to Councillor Waud on 20 September 2020 regarding my request to repaint double safety lanes at a no stopping blind corner in my street which is very narrow and has a history of head on collisions. The road paint has deteriorated over time and needed renewing for the safety of vehicular traffic and residents residing in the bend area. TO DATE, I HAVE HAD NO REPLY TO MY LETTER.

On 30th October 2020, I copied my note (to Councillor Waud) to Bankstown Mayor Asfour with a renewed request for him to assist in the actioning of this small amount of road and safety maintenance. DO DATE, I HAVE HAD NO REPLY.

In my view, if a Council disregards correspondence of this nature (concerning road safety) and disregards the quality of its residential surrounds, it certainly does not deserve an increase in ratepayers funds as described in their letters to ratepayers lauding their decision to increase their rates in the 2022 rate year.

My wife and I object to a rate increase most strenuously and think that our current rates of \$2000 per annum is today, far above Council's worth.


A 30% increase is frankly an insult ... when we are in the middle of a pandemic! People are struggling to make ends meet already.







I live in Padstow, in the Canterbury-Bankstown council area, and have been a rate payer for some 13 years. I'm disappointed at the new rate structure, that the increases seem to disproportionately be targeted toward the lower-value properties, with only a minor increase to the higher-value properties.

Even if we assume that the increase is warranted, ratepayers are being told by council that the harmonisation process is just following state government instructions. It seems that a significant rate increase is not part of the state government instruction.

With CPI growth forecast by the RBA to be at best 3% in the next few years (https://www.rba.gov.au/publications/smp/2021/feb/forecasts.html), where are we getting these 7.8% rate increases from?

How did council reach the conclusion that it is necessary to increase the base rates from \$636.80 to \$1,040? Is this an equitable share of the cost burden across all properties, or simply an attempt to push through a rate increase without much scrutiny, and pin the responsibility on the state government?

While the adjustment in the first year seems moderate to those in the former Canterbury city council, those who have land values below \$400k are still seeing a \$100+ rate increase for 22/23 and 23/24 - this is not a harmonisation process, it's simply a rate increase.

I would ask that you have a look into this process to ensure its fairness. A council should not be blaming its desire for a rate increase on the state government, especially in these economically unstable times.

What is the increase to be spent on and is it necessary?



dollar cost saving

I am utterly outraged that the council is planning to increase rates by more than 30% when there is a significant cost-saving project that has been shelved by the council.

Below is my conversation with the council over the last few years about implementing a system to convert organic garbage into compost. A trial has been conducted, but the project was shelved. Since 2009 the Penrith Council have had a large-scale organic garbage system and has saved 17 million dollars in tip fees and avoiding organic garbage contributing to greenhouse gases. This project would address both a major environmental issue and provide the opportunity to keep our council rates as low as possible.

The main reasons given to me why the project was not implemented was that:

- It appears it is more important to the council to "allow for our diverse community to participate in ways that works for them and their families" in managing organic compost waste, rather than making sure our council fees are kept to the minimum. I would suggest that this priority is wrong - most people would prefer to slightly modify their garbage disposal habits (i.e. put organic garbage in a different bin) and not have a rate increase.
- 2. The participation levels were low in the trial. The reasons for this may be varied (i.e. all household members perhaps didn't clearly understand the trial system and what required) and does not automatically imply that people will not adopt the system if it was implemented. I believe that if people understand that it is good for the environment and good for keeping rates low there would be increased participation. Other councils I'm sure have faced this challenge and overcome it.
- 3. Contamination problems (6% contamination levels in stand-alone dwellings and over 30% contamination levels in units/apartment dwellings). I feel that this is more an education issue and over time providing feedback to households, this would improve. Penrith council have staff that inspect bins and provide feedback to households that haven't got it right to change their behaviour. Over time they have reduced their contamination problems. And for those that don't want to comply after giving significant feedback to the household I'm sure the threat of a fine will help with compliance to the procedure.

I am confident that our council staff can find ways to meet all of the challenges to ensure a successful implementation of this project. There is I'm sure a lot to learn from other councils that have implemented this system.

Some suggestions the council may wish to consider:

1. Create on the council website a project classification called "Cost reducing

- projects" and put this project up on the website. Allow the project to be followed by sending email updates.
- 2. Send a letter to every household asking them to set up a profile on the website (if not already done so) and request them to vote on the project online. Collect their residential address as well when setting up their profile (just in case you need in future to provide specific household feedback about the new organic garbage disposal system process). With email addresses of the community this will allow the council to cost-effectively continually educate the community on the new organic garbage system and any other council process that requires educating the community (e.g what recycling specifically goes into the council yellow bin).

We expect councils to deliver services in the most efficient manner. I personally expect the council to take the lead and protect our environment. I am confident that most community members would applaud the council's implementation of this project - particularly if the council can revise downwards the extent of the rate increase or abandon it all together.

If I can be of any assistance in implementing this project I would most welcome the opportunity. I am a business analyst by trade and have had significant corporate experience in managing systems and processes.

I recently received notification from Wendy Lindsay MP that Canterbury-Bankstown Council are proposing to increase their council rates by more than 30% over the next 5 years.

I write to you express my concern over this proposed rate hike. I argue this is in contrast to CPI and the demographic reflected by Household Income statistics.

The past 5 years has shown a a less than 2.5% increase in CPI across Sydney, and less than 2.2% across Australia overall*. More recently the CPI change from 2019-2020 showed a decrease by up to 1%*. Going back 20 years the highest change in CPI has been less than 6.5% for Sydney!* These numbers are in clear contrast to the proposed 30% increase which Canterbury-Bankstown Council wish to implement. I argue that any rate increase should be reflective of the increased value of the dollar and therefore reflective of the cost of living within the state.

Recent numbers show that Canterbury-Bankstown Council Lowest and Medium Lowest Household Income groups combined make up over 56% of total households**. In 2016 this reflected a weekly income of less than \$1482**. Rate increases should take into account the disposable income of these households, especially since they make up more than 50% of the Canterbury-Bankstown Council demographic.

Please insist that Canterbury-Bankstown Council revise their proposed rate increase to reflect the community demographic.

CAPITAL EXPENDITURE (CAPEX)

Council's CAPEX is now expected to be **\$161.4M**, a net increase of \$15.8M to that previously projected and adopted.

The variation largely relates to \$12.0M of Federal Economic Stimulus funding received by Council for identified projects to be completed over the next 12 months. Other revisions relate to timing adjustments of budgeted expenditure that will not be completed or commenced within the 2020/21 financial year and have now been rescheduled to the 2021/22 financial. I kindly request that IPART accept this late submission in relation to the Canterbury Bankstown Special Rate Variation & Rate harmonization.

The material in this late submission only became public knowledge on Friday 19th March 2021 at the Canterbury Bankstown Council event held at the Bankstown Sports Club "CBEvolve". In this event it became apparent Council had taken over all the detailed planning for the NSW State Government initiative for urban renewal of the Sydenham to Bankstown corridor,

- The quality of the presentations and detail in the town plans is similar to what the NSW Government has put into the North-West Metro and other significant infrastructure investments, this is significantly different to what one would expect from a local council.
- This Urban Renewal strategy has intergenerational benefits and Gross Domestic Product benefits broader than the LGA. This level of activity is usually a State or Federal Government activity.
- The intergenerational and widespread benefits of the urban renewal should not be funded by today's Canterbury Bankstown rate payers as they are not the principal longterm beneficiaries.

The genesis of the CBCity adoption of the delivery and funding of the initiative happened while the newly merged Council was under the administration of **Exercise**. There was no community endorsement to fund the required detailed planning required.

The following dates and events are pertinent to my submission:

The table below headed Canterbury & Bankstown Fit for the future assessments for both former Council LGAs satisfied the Financial, sustainability, Infrastructure / service management and efficiency Independent Local Government Review Panel criteria. Canterbury Council provided evidence that it would have met the Scale and Capacity criteria by 2021.

2016

12th May, the former Canterbury & Bankstown Councils were merged to create the new LGA of Canterbury Bankstown by the NSW Government.

At the Council meeting minutes from September 27th 2016 detail when Council officially engaged with NSW State Planning minister Rob Stokes on the Sydenham to Bankstown Urban Renewal Corridor strategy. The Council minutes list the Director City Planning as Scott Pedder and the Manager City Planning as The 1st item on the Council minutes is for the Administrator Richard Colley to write to the minister.

ITEM 4.1 INVITATION TO MINISTER FOR PLANNING TO VISIT CAMSPIE CENTRE

(150) MOVED AND RESOLVED BY THE ADMINISTRATOR

That I write to the Minister for Planning and invite him to join me to visit Campsie and to see first-hand the opportunities the Campsie town centre has to offer in supporting the State Government's intentions under the draft Corridor Strategy and to highlight some of the key issues that will need to be addressed in the Sydenham to Bankstown Urban Renewal Corridor Strategy when released later this year.

The following <u>25 OCTOBER 2016 Council minutes</u> record that with a new "Director' level position with the title "Director City Future" indicating Council had adopted a new focus.

This focus was sufficiently different to the existing "City Planning" function to warrant a Director level position reporting directly to the General Manager. This change of focus was done under the direction of the Administrator , as such no mandate was sought or granted by rate payers. While the Director role at this time was not a material change to Council's functions at the time, it does become materially different when the NSW State Government hands over planning control for the urban renewal corridor in late 2018.

2017

In the <u>2017/2018 Annual report</u> (page 92) it is noted the "Liveable Centres Program" was established and provided approximately \$3 million per year for funding planning and works for 18 centres across the City to 2021.

From June to September 2017 the <u>NSW Government put a DRAFT Sydenham to Bankstown Urban Renewal Corridor Strategy on exhibition</u>. More than 2,800 submissions were received raising a range of issues, including infrastructure, open space, employment lands, affordable housing, transport and traffic, density, urban design, heritage and local character.

NSW Government Documents relating to 2015 and 2017 draft Strategies

2018

On 23rd November 2018 the NSW Government materially altered the planning approach for the urban renewal corridor in response to community submissions. The <u>NSW Planning Minister Anthony Roberts announced</u> he would be handing planning control for the Sydenham to Bankstown corridor to the Canterbury Bankstown Council. It is important to note here that the

scope and intergenerational benefits of this task is not normally a Council activity and had not changed from the original State strategy.

Context of where the Sydenham to Bankstown urban renewal strategy came from is important. It flows from the Federal Government "Smart Cities Plan" which fed into the NSW State Premier's "Priorities", that created the "Greater Sydney Commission who developed the "Towards Our Greater Sydney 2056" plan and 6 Sydney District Plans. Based on the West Central District Plan, Planning NSW created the "Sydenham to Bankstown Urban Renewal Corridor" strategy. This strategy is closely linked to Transport NSW's Sydney Metro City & Southwest project that has similar lineage but is State Government funded.

The Sydney Metro City & Southwest business case Project justification states "the city-shaping benefits of Sydney Metro City & Southwest is linked to the increase in patronage from more people living and working along the corridor". The business case goes on to state "The opportunities of high- or medium-density infill development associated with more people wanting to live and work along the Sydney Metro City & Southwest corridor will provide substantial savings in infrastructure provision for government."

The number of times the Sydenham to Bankstown Metro is referenced in Council's various planning documents also affirms the linkage. Citywide-shaping on this scale is not normally a Council activity. Again, the intergenerational and widespread benefits of this urban renewal should not be funded by today's Canterbury Bankstown rate payers as they are not the originators of the strategy, nor are they the long-term beneficiaries of it.

Contrary to what Council advise, the genesis of the strategy came from Government, rate payers when consulted may have agreed the outcomes described are desirable. However, there is no evidence of rate payers providing informed consent to paying for the long-term urban renewal benefits with an unforeseen rate increase.

Financial impact of change of planning control

As I have pointed out in previous submissions to IPART, Council has gone from having a healthy balance sheet \$41m annual surplus in 2016/17 to the current forecast deficit of \$53 million in 2021/22, requiring a \$63 million SRV annual lift to address it.

I can't help but notice that the turnaround in Council's balance sheet coincides with Council taking on the NSW Government's planning control responsibilities for a strategic initiative. It is a stark contrast to the forecast financial benefits stated in the <u>2016 NSW Government merger proposal of the Bankstown & Canterbury Councils</u> into a single LGA. The forecast \$94 million benefit over 20 years that has not been realised. Employee benefits & on-costs have increased from \$122.5 million in 2017/18 to \$147 million in 2020/21, up 17%.

It is unclear where the additional employee costs have come from, however, it is conceivable that the additional planning staff and planning consultants may account for the increase in costs and erosion of the 2016/17 surplus.

Council has long argued the NSW State Government has been cost shifting to local Governments. The November 2018 transfer of planning control also transferred the financial cost to Council. I am unable to find a reconciliation of the cost of taking on the State Government's planning role and State Government grants

As a rate payer I ask IPART to quantify exactly how much Council invested of rate payers' funds in the planning and resourcing for the Sydenham to Bankstown urban renewal corridor.

It is noted that Council purchased state of the art CGI software to produce animated 3D graphics used in the CBEvolve presentation, I'm aware that such software and skilled personnel to use it come at no small cost, I believe rate payers would appreciate transparency on this cost also.

At the conclusion of the CBEvolve function hosted at the Bankstown Sports club on Friday 19th March, all attendees were given a gift bag with a Samsung video player that played on a loop the virtual reality presentation we saw at the start of the event, rechargeable via micro USB cable.

I have created a video of the virtual reality presentation and put it up on Google Cloud for anyone to view. It is too large to put in an e-mail. Here is the link

Again, the quality of the presentations and detail in the town plans is similar to what the NSW Government has put into the North-West Metro and other significant infrastructure investments, this is significantly different to what one would expect from a local council.

New Campsie & Bankstown Master Town Plans

The investment Canterbury Bankstown Council has made in planning urban renewal, revaluation of Council's buildings and the accelerated depreciation rates explained in my previous submissions appear to be a Council management crafted position where rate payers are being asked to fund the NSW Government's urban renewal strategy planning stages. I argue, a strategy that has intergenerational benefits, today's rate payers should not fund.

On a final note, Council taking on Planning Control for such a large State Government endeavor or whatever else Council is doing that consumes all available rate revenue appears to be in conflict with one of the NSW Local Government act "Principals of local government"; "Councils should ensure that the strategic goals and activities to work towards them may be achieved within council resources". The recent turnaround in Council's balance sheet, commensurate SRV and maximum rate harmonization IPART applications show Council is not functioning within Council financial resources.
