## NOTIFICATION OF INTENTION TO APPLY FOR A SPECIAL RATE VARIATION

The City of Newcastle would like to advise the Independent Pricing and Regulatory Tribunal of our intention to make an application for a multi year Special Rate Variation under Section 508A of the Local Government Act 1993.

The City of Newcastle has undertaken extensive financial analysis through the development of our current Long Term Financial Plan (LTFP). Our analysis has confirmed that Council's program of expense reduction and containment of capital works programs, whilst resulting in substantial financial improvement is not sufficient to reach a position of financial sustainability. Further action is required to ensure there are sufficient funds to address Council's infrastructure backlog whilst ensuring a sustainable cash position is maintained.

Council has considered and analysed five options or scenarios. Two of the five options will meet the sustainability objectives. Both of these options rely on Council's ability to raise additional revenue through a special rate application. The LTFP shows that a Special Rate Variation is required to secure Council's future financial sustainability by achieving and maintaining an Operating surplus by the 2018/2019 financial year, reducing the Asset Backlog within the 2% cap, and maintaining cash levels to appropriately cover future anticipated liabilities.

Following thorough consultation with the community through our Road to Recovery engagement program, the feedback received indicates sound community support for a Special Rate rise in order to facilitate financial sustainability and continued services.

Newcastle Councillors have considered the financial analysis and community consultation information and have resolved to support a Special Rate application for the City of Newcastle for a rate rise of 8% per year, over five years, commencing from 1 July 2015. The increase is inclusive of the rate peg and each rate rise would remain in the base rate going forward.
