Hurstville apartment owners/residents represent the majority of people in Hurstville but we see no rewards for our environmentally conscious and small efficient living.

Hurstville CBD streets are generally dirty with regular homeless people and beggars loitering around the main street including the plaza where dangerous acting people congregate in the evenings.

You seem unable to enforce or enact bylaws for the upkeep of dilapidated looking shop fronts and buildings in the main street. You also seem to ignore street hawkers in the main street selling vegetables in the evenings.

You seem apathetic to the constant dumping of shopping trolleys that are major accidents waiting to happen when they roll downhill crashing into people and cars on busy streets like Forest / Queen / Railway Pde.


I read that six directors earn \$290,000 each, plus the general manager on \$460,000?

I am against the Georges River Councils proposal for special rate variation to IPart for the Rates harmonisation increase for the following reasons:

The council do not in any way show me that they are efficient at cost saving for our area.

There are no cost savings put forward in the last few years that benefit the community in any way.

The only way the council seem to gain any substantial funds to reduce their debt for the area is to sell off assets, which belong to the community. I refer to a few local car parks that benefit small business in our area. Misleading facts provided of 60 cents per week as opposed to previous increases of \$1 to \$3 per week increase in 2019




