I am writing to express my concern in regards to Armidale Regional Council's (ARC) recent application to IPART for a special rate variation (SRV). I wish state my desire for no SRV (the discontinuation of the current SRV).

I have made this decision for two reasons
Firstly, the region is currently suffering from the
economic impacts of drought, bushfire and the
covid19 pandemic. An SRV will only add to these
pressures.

The council has a demonstrated track record of chronic financial mismanagement. The provision of increased finds to ARC will only increase the mismanagement. It is my view that the council should reduce its operations to core responsibilities. Your comments on Criterion 1:

The senior ranking officers of the Armidale Regional Council have continually demonstrated that they are irresponsible in the allocation of ratepayers funds, leading to a situation where they cry broke and call on the ratepayers to bale them out.

Why should the ratepayers foot the bill so that they can continue on their merry way with little or no accountability.

Your comments on Criterion 2: This information has been scratchy at best, with the all inclusive percentage rise for me and my wife as ratepayers completely hidden. We have not received any information which lists "ALL" the rate increases that will impact on us. Your comments on Criterion 3: What is reasonable? We were asked to conserve water through the drought, which we did, and because the Council are now not selling enough water with the drought over, they have doubled the water rate charges per KL. I understand that the standing charges are going to increase as well but have not been informed as to what that will be. Same, same with waste disposal charges. Tip gate fees are haphazard at best, with the cost of disposing a mattress at around \$70. No wonder people are dumping them in bush locations, or filling up trade skip bins when no one is around. Your comments on Criterion 4: Not sure where they are exhibited? Your comments on Criterion 5: If there are any improvements in performance, it has not been visible at all. The continued spending on yuppy, faddy, useless projects that will never be of benefit to the ratepayers, the community, or the region, continues unabated.
