Re: Special Rate Variation - Clarence Valley Council -

My husband and I are aged pensioners, and have lived for nine years now. Originally from Western Australia, we have lived most of our eighty years on the Gold Coast, and had our best years there before the population explosion created traffic problems, water, and other services problems. As long time member of surf lifesaving the beaches were the attraction.

We have been only wage earners, but have travelled on a budget to many countries, so have been able to observe. Travelling frequently back to Western Australia, with the beautiful roads, trains, and prolific pathways and bikeways, we know what can be achieved when one doesn't live with floods.

Just about everyone who resides within the Clarence Valley Council area appreciates the problems associated with floods, and the continued problems associated with upkeep of the many roads and the bridges with access to the many of the 100 islands.

HOWEVER - most of us cannot afford another Rate rise.

In Iluka and Yamba we have seen the installation of sewerage over the last two years, eventuating in a rate rise. We appreciate that it had to be done – with so many back yards with fishing boats, the thought of fish rubbish and sewerage swirling around in a flood was non-acceptable.

Our Notice of Valuation decreased \$21,000 from July 2010 to July 2013 - Previously it was zoned as Low Density Residential, and in 2013 – Residential. Our rates still continue to rise.

Our home hasn't gained in valuation, despite money spent on improvements on home and large yard.
