Please leave your comments in the comment box below.	Our Council has misrepresented our community very badly for many years and the financial implications of an SRV on ratepayers following drought, bushfires and now COVID will be the last nail in our coffin.
	Our ratepayers have also had imposed on them, outrageous costs from a 'court case, where effectively our Council took our Council to Court, which was never going to end well.
