Overview

IPART wishes to begin using SharePoint 2013 to display events in an easy to read manner. A branded home page with a CEO Blog, Branded and a Newsfeed is also required.

There are 2 main requirements from IPART for this first phase of utilising SharePoint 2013:

1. Landing/Home Page

2. Events page

Home Page

A home page is required by IPART to become the landing page for SharePoint 2013. The page will have

- A calendar view
- Newsfeed
- Blog from the CEO
- Links to systems, websites and documents
- IPart look and feel

The look and feel will align with the IPart website. The same fonts, colours and logo will be used and the page will be laid out in an appropriate way.

Events Module

IPart would like to see a view of all of the events, papers, briefings etc in one place. Having everything displayed in a calendar is overwhelming, and the information needs to be presented clearly.

The events will work as follows:


1. The event information is entered in an outlook calendar appointment, so as to invite certain people to that event. The title, date, attachments and invitees are created in Outlook.
2. A SharePoint calendar needs to be invited also as an additional invitee.
3. The main information appears in SharePoint, in a SharePoint calendar.
4. In SharePoint additional metadata can be added for each event. Eg select 'ESS Committee Meeting'. This is very quick to do. The event will then appear in the ESS Committee Meeting box on the page.
5. A Search page will be provided to search on events, including past events.
6. Events can be filtered and refined by their various types and combinations
7. Hovering over an event title will show a brief description in a popup
8. Clicking event title will show a detail page for the event
9. 'My Calendar' option will allow user's personal appointments and meetings to be included in the listings. Each user would have to enter his/her login credentials for first time setup.
10. On the Events main page, the next 5 events will appear in each box.
