The application also refers to the applicant's intention to seek such a licence for other residential community sites, however, no details on these sites have been included. Therefore, the Department is not in a position to comment on these additional sites.

The Department has previously advised you on planning matters concerning the Pitt Town and Central Park sites (dated 9 August 2010 and 4 April 2012 respectively). That advice remains applicable to the subject application and is attached for your information.

Drinking water and recycled water servicing infrastructure for parts of the Discovery Point site were granted project approval under Part 3A of the *Environmental Planning and Assessment Act 1979* on 19 March 2012 (application 10_0030) and 18 July 2012 (application 10_0031). Therefore, in light of these planning applications and the environmental impact assessment undertaken to date, there are no outstanding land use planning issues with respect to these two projects.

Please note however, the remaining areas of the Discovery Point site that may require water cycle servicing infrastructure would be subject to Development Applications, for which approval from Rockdale City Council is required. Therefore, you should consult with Rockdale City Council with respect to such works.

Dear Mr Reid

I refer to your correspondence in relation to the application made by Pitt Town Water Factory Pty Ltd under the *Water Industry Competition Act 2006* (WICA) for a network operator's licence and a retail supplier's licence.

The licence applicant proposes to treat and supply recycled water for non-potable uses within the residential subdivision at Pitt Town (the Pitt Town Release Area). Concept plan approval was granted to Johnson Property Group for the Pitt Town Release Area under the *Environmental Planning and Assessment Act 1979* (EP&A Act) on 10 July 2008. The concept approval included the provision of related infrastructure, including water supply mains and sewerage mains. It is noted Johnson Property Group, as part of the concept plan approval, had a sewer servicing strategy in place, which was prepared in consultation with Hawkesbury City Council. However, Johnson Property Group and Pitt Town Water Factory Pty Ltd have developed an alternative sewerage strategy to service the release area (the proposal). This alternative may alleviate the need for major sewerage infrastructure works at McGraths Hills arising from the development of the Pitt Town Release Area.

I note and agree that Part 3, Division 18, clause 106 of the *State Environmental Planning Policy (Infrastructure) 2007* would only apply to the proposal after a licence under the WICA has been granted. As such, this would result in a planning assessment process under Part 5 of the EP&A Act after such a licence is granted. I am advised that the Department of Planning is undertaking ongoing discussions with the Independent Pricing and Regulatory Tribunal and the NSW Office of Water, with regard to the application of the *State Environmental Planning Policy (Infrastructure) 2007* to the WICA licensing process.

I also wish to draw your attention to the following issues that should be considered during the assessment of the proposal. Firstly, Hawkesbury City Council should be consulted to ensure the proposal is consistent with any development application it may be in receipt of for the carrying out of works associated with the Pitt Town Release Area, under Part 4 of the EP&A Act. Secondly, I note at the time of the concept plan approval for the Pitt Town Release Area, Johnson Property Group were in the final stages of constructing a water trunk main from a connection point at Windsor Road through to Pitt Town, as approved by Sydney Water Corporation. Therefore, Sydney Water Corporation should be consulted in addressing the water cycle and servicing management plans for the area. Lastly, in large flood events, the Pitt Town area becomes isolated and accordingly the NSW State Emergency Services (SES) has devised an evacuation plan for the area. The SES should be consulted in determining whether the proposed water recycling facility can be developed at Pitt Town without major flood evacuation route upgrades.
