

SUBJECT: I OPOSE AND STRONGLY OBJECT TO WAGGA WAGGA CITY COUNCIL'S APPLICATION TO THEIR ADDITIONAL SPECIAL VARIATION (ASV) 2022-23

I oppose and strongly object to Wagga Wagga City Council's (WWCC) application to their Additional Special Variation (ASV) as WWCC has not considered all the impacts on the ratepayers and the Wagga Wagga Ratepayers, Residents and Community in 2022/23 and future years.

The ratepayers and residents of Wagga Wagga are facing increasing pressures on their budgets with rising interest rates, rising petrol prices, rising inflation, increased insurance premiums, lack of and increasing costs of affordable and appropriate house and other increasing costs of living.

The Reserve Bank of Australia (RBA) https://www.rba.gov.au/ recently increased interest rates to 0.35% and to curb inflation which is at 5.1% and has indicated that there will be further increases in interest rates which will put more pressure on the budgets of the residents, ratepayers and the Wagga Wagga Community.

WWCC has failed to properly consult with the Wagga Wagga ratepayers and community as not everyone has a computer, smartphone or is on social media or cannot afford to purchase newspapers on a daily basis to access the information on the ASV.

2. Evidence that the community is aware of the need for and extent of a rate rise. The Delivery Program and Long Term Financial Plan should clearly set out the extent of the General Fund rate rise under the special variation. In particular, councils need to communicate the full cumulative increase of the proposed SV in percentage terms, and the total increase in dollar terms for the average ratepayer, by rating category. Council should include an overview of its ongoing efficiency measures and briefly discuss its progress against these measures, in its explanation of the need for the proposed SV. Council's community engagement strategy for the special variation must demonstrate an appropriate variety of engagement methods to ensure community awareness and input occur. The IPART fact sheet includes guidance to councils on the community awareness and engagement criterion for special variations.⁵

Internal / External Consultation

Internal consultation was conducted with Councillor's as part of the Budget Workshop on the 4 April 2022.

IPART will not require Councils to demonstrate external community consultation outside of the 2022/23 Integrated Planning & Reporting (IP&R) standard public exhibition period requirements as detailed below.

The IP&R suite of documents will be placed on public exhibition for a 28-day period commencing from 3 May 2022 and concluding on 4 June 2022. As part of this exhibition period a variety of communication methods will be used, to not only promote the public exhibition period but also promote the purpose of the documents.

With the information provided, WWCC has not clearly shown the impact of any rate rise on the community and ratepayers as per the following IPART NSW extract:

- 3. The impact on affected ratepayers must be reasonable, having regard to both the current rate levels, existing ratepayer base and the proposed purpose of the variation. The council's Delivery Program and Long Term Financial Plan should:
 - clearly show the impact of any rate rises upon the community,
 - demonstrate the council's consideration of the community's capacity and willingness to pay rates, and
 - establish that the proposed rate increases are affordable having regard to the community's capacity to pay.

I will also mention that the discussions regarding the ASV at the WWCC meeting on Monday 11 April 2022 was held in the confidential closed session of their livestreamed meeting https://wagga.nsw.gov.au/the-council/council-meetings/council-meeting-livestream and the minutes



The Wagga Wagga residents and ratepayers have no idea of what was discussed during the confidential closed session of the meeting.

Instead of applying for an ASV WWCC should cut the fat from their budget and operations and reduce the number of Code of Conduct complaints etc. The following information shows that WWCC was granted a Special Variation (SP) in 2016-2017 of 5.63% to remain in them rate base for five years to 2020-21 to upgrade the levee bank around Wagga Wagga. https://www.ipart.nsw.gov.au/sites/default/files/documents/lg_determination_-wagga_wagga_city_councils_application_for_a_special_variation_for_2016-17_-may_2016.pdf

Wagga Wagga City Council (Wagga Council) applied for a temporary special variation for 2016-17 of 5.63%, to remain in the rate base for five years to 2020-21.2 We have assessed the council's application, and decided to approve the variation as requested. We made this decision under section 508(2) of the Act.



The Wagga Wagga residents and ratepayers are still recovering from this SP and there were issues with the project management and engagement of contractors with the upgrading levee project which lead to delays and I am lead to believe substantial cost overruns.

The potential uncertainties around some of Council's planned major projects have the ability to have a significant impact on the Long Term Financial Plan, both in regards to timing and costing and the utilisation of funding sources.

Levee Bank Upgrades - Upgrades of Main City Levee and North Wagga Levees

Wagga Wagga City Council have recently completed Stage 1 and 2 of the Main City Levee Upgrade which has upgraded the Main City Levee to a 1 in 100-year level of protection.

The Floodplain Risk Management Advisory Committee has commissioned an independent peer review of the North Wagga component of the overall Floodplain Risk Management Study and Plan. The review will look at the process surrounding the risk assessment strategy and consultation processes for all flood mitigation options proposed for North Wagga.

The original estimated cost of upgrading the Main City Levee to a 1 in 100year level of protection and upgrading the North Wagga Levee to a 1 in 20 year level of protection is \$23.3M.

The total capital cost indexed over the five year period is as follows:

With the commitment of Federal and State funding for the project, Council is funding its one-third share of the cost from a Special Rate Variation (SRV) which commenced in 2016/17 and concluded in 2020/21.

The modelling assumed a construction period of five years, but this is conditional of the timing and conditions of funding from NSW Office of Environment and Heritage.

LONG TERM FINANCIAL PLAN 2021-2022

The Riverside – Wagga Beach Landscape Project mentioned in the above table is constructed on a known flood prone area:









As mentioned previously the grandiose projects do not benefit all the Wagga Wagga residents and ratepayers such as the Pomingalarna Multisport Cycling Complex Active Travel Plan:



The airport is costing the Wagga Wagga residents and ratepayers an arm and leg every year and not all the residents and ratepayers use the airport and as the Coalition lost the election the Federal Government funding is not on the table so WWCC will need to secure additional funding to complete this project:

The projects listed in the previous table were over \$5 million and WWCC should list all the projects less than \$5 million.

WWCC recently purchased the old Ambulance Station building located at 56 Johnston Street Wagga Wagga for an amount of what I am lead to believe was in the range of \$600,000. The following sentence was extracted from https://aboutregional.com.au/old-wagga-ambulance-station-to-be-returned-to-its-rightful-owners/ and states, 'The council initially hoped for the return of the building to the local community for a "peppercorn fee", according to director of Regional Activation . While the NSW Government indicated it was valued at \$1.2 million it is not yet clear what price the two parties eventually settled on.' 



Other issues that WWCC are not getting on top of is the condition of the roads as can be seen by the potholes in the following photos:
