Petition To Strongly Oppose Richmond Valley Council's Application For a SRV 2019.

Dear Members Of IPART,

Please find attached the signatures of 360 Richmond Valley Ratepayers and Citizens who wish to strongly oppose RVC's application for a Special Rate Variation for the next four years of 5.5%. The reasons for the objections are clearly stated on the front page of the petition.

RVC states in it's application that, after extensive community consultation by Council which involved 404 residents by phone survey ,55 residents chose to respond to an online survey from Council's website, and 33 residents attended 2 community meetings at either end of the council area. That is a total of 492 residents or less than 2% of RVC's population. Council state that 66% of community were in favour of

a SRV of 5.5%. That is using the figure of 26% who indicated that they were "somewhat supportive". This 26% was added to the 40% who responded to the phone survey as being supportive or very supportive. What does "Somewhat Supportive "mean? It is somewhat dubious to say the least ,to add this 26% to the supportive group This displays a classical example of using statistics to suit your end means.

It was very interesting as we gathered signatures for this petition that at least 90% of residents were not aware of Council's application for a Special Rate Variation. While realizing it is difficult to reach everyone, maybe Council should reconsider their extensive Consultation practices in the future.

If Council has 66% of the phone survey of 404 residents somewhat or in favour of an SRV of 5.5% increase that is approx. 266 residents .This petition has 360 strongly against any SRV . Add this to an online petition you will receive shortly, another 260 plus residents also express their strong objection to Council's application. That is over 620 residents objecting ,which is far greater than those "Somewhat "in favour.
