All landfill on this floodplain will displace flood water and elevate flooding levels unless matched by equal excavations elsewhere on that floodplain. The Kingscliff Sands mine may be doing that, but have the maths/hydrology studies been done?

With the valuer general's new land valuations coming, rates in the Shire will be adjusted for that year increasing rates and councils income. It is premature for council to be proposing this increase without knowing the full impact to its ratepayers! It is prudent for council to revise its expenditure and services provided to ratepayers like any other business, and to ensure that the council is providing their ratepayers with the necessary amenities and services. Whilst it might be nice for council to put on more staff to reduce DA application processing times. Council needs to revise and ensure their processes are relevant and necessary for the area before increasing rates. The NSW Government's removal of the Environmental Enforcement Levy at the beginning of 2022 council should have been aware of it's timing and removal way before it happened and budgeted accordingly. First, whilst Tweed residents particularly in coastal locations have experienced significant land value increases, such benefits do not benefit individuals' cash flow. Second, substantial increases in cost of living driven by strong inflation recently have compounded financial pressure on families, especially given wage stagnation over the past decade. In short, most working families have not experienced an uplift in income to service price increases demanded by suppliers and government authorities. Working families have had to re-assess their budgets and make reductions in discretionary spending to cope with cost of living pressures. In contrast, local government authorities seem to be diversifying their programs further away from the core purposes which local government have traditionally served. In the current environment of cost pressures, it is incumbent on all government authorities to exercise fiscal restraint and not lean on already their already financially-stressed communities to fund an ever-growing range of services. Particular attention should be paid to where local government services overlap with state and federal programs, such as those intended to support identified groups based on gender, age and ethnicity. Tweed Shire Council should look closely at its internal structure before passing further costs on to the local community.
