 - **SLAB, FOOTINGS ETC:** Prior to pouring any in-site reinforced concrete building element, pad footings etc.
 - **d) FRAME:** Prior to covering of the framework for any floor, wall, roof or other building element.
 - e) WATERPROOFING: Prior to covering waterproofing in any wet areas.
 - **f) STORMWATER:** Prior to covering any stormwater drainage connections.
 - **PLUMBING/SEWER:** Prior to covering any hot and cold water service pipes, sanitary drainage and sanitary plumbing systems while under pressure test.
 - **h) FINAL:** After the building work has been completed and prior to occupation or use of the building.
- **3. TERMITES:** A termite barrier system is required to be installed to deter concealed entry of termites into the building. The termite barrier system is required in accordance with Part 3.1.3 of the Building Code of Australia. A durable notice must be fixed to the building in a prominent position indicating: (1) the method of termite management, (2) date of installation of system, (3) life expectancy of barrier (if chemical barrier is used) and (4) scope and frequency of future inspections for termite activity.

Note: Termite barrier systems can be provided by various means including chemical or physical barriers or a combination of both. Australian standard 3660.1 provides detailed information.

- **4. STREET NUMBER:** Prior to occupation of the dwelling the street number allocated to the premises shall be displayed so that it is clearly visible from the road adjacent to the front of the allotment.
- **5. BASIX:** Under Clause 97A(3) of the Environmental Planning an Assessment Regulation 2000, it is a condition of this development consent that all the commitments listed in each relevant BASIX Certificate for the development are fulfilled. In this condition:
 - a) Relevant BASIX Certificate means:
 - i. A BASIX Certificate that was applicable to the development when this development consent was granted (or, if the development consent is modified under Section 96 of the Act, a BASIX Certificate that is applicable to the development when this development consent is modified); or
 - ii. If a replacement BASIX Certificate accompanies any subsequent application for a Construction Certificate, the replacement BASIX Certificate; and
 - **b)** BASIX Certificate has the meaning given to that term in the Environmental Planning and Assessment Regulation 2000.
- **6. EAVES GUTTERS:** High fronted eaves gutters are to be designed with an acceptable overflow measure to ensure overflowing gutters do not result in water entering the building. See Section 5 (Figure 5.3) of AS 3500.5.2000.

Reason: To comply with requirements of BCA Part 3.5.2.4(d) and AS 3500 and to minimise risk to building in event of blocked gutters due to hail, debris or overloading during a storm event.

- **7. SANITARY PLUMBING AND DRAINAGE:** All sanitary plumbing and drainage work shall only be carried out by a licensed plumber and drainer and no work is to be covered over or concealed from view until it has been inspected and approved by the Approval Authority.
- **8. REQUIREMENTS FOR H1, H2 and E SITES:** Drains attached to or emerging from underneath the building shall incorporate flexible joints immediately outside the footing and commencing within 1 metre of the building perimeter. This requirement applies to all stormwater and sanitary plumbing drains and discharge pipes (AS2870, Section 5.6.4).
- **9. WET AREA FLASHING** The wet area flashings are required to comply with AS3740-2004. It is recommended that wet area flashings be installed in accordance with "Guide to Internal Wet Area Waterproofing" issued by the Master Builders Association Waterproofing Council (NSW). This guide sets out the industry best practice for waterproofing and compliance with the guide will ensure the highest standards are achieved.
- **10. SMOKE ALARMS:** Provide smoke alarms in accordance with Part 3.7 of the Building Code of Australia. The alarms are to be located on or near the ceiling between each area containing bedroom and the remainder of the dwelling. The alarms must be connected to the mains power and have a battery backup.
- **11. KITCHEN EXHAUST FANS AND DUCTS:** Exhaust fans and ducts provided in a kitchen must be installed in accordance with the provisions of AS 1668 "SSA Mechanical Ventilation and Air Conditioning Code". A flue must be provided to discharge exhaust gases to the outside atmosphere.
- **12. FLOOR LEVELS:** The floor level of the building shall not be less than 300 mm above the finished level of the ground surrounding the building.

- **13. TIE DOWN AND BRACING:** Details of the method of tie down and bracing for the building are to be submitted to Council prior to the construction of the frame.
- **14. BALUSTRADES:** All balconies/decks 1 metre or more above ground level must be provided with an approved balustrade. Balustrades to be 1 metre above floor level for balconies and 865 mm above floor level for stairs. No part of the balustrade shall allow a 125 mm diameter sphere to pass through (BCA 3.9.2).
- **15. ROOF TRUSSES:** Manufacturers details of the roof trusses showing bracing, tie down, connections and support points are to be provided to Council prior to the construction of the frame.
- **16. USE OF PUBLIC LAND:** The nature strip/footpath/roadway shall not be used for the storage of building materials i.e. sand, bricks, timber etc. The public land outside the property is to be maintained in its original condition to enable safe pedestrian access past the site at all times.
- **17. ADVICE:** For all works on the footpath/nature strip or roadway, please contact Council's Engineering Department on (02) 6033 8960 to obtain the necessary permits and construction standards.
- **18. SITING:** The carport shall stand wholly within the property boundaries without overhang or encroachment onto adjoining land. It is the responsibility of the owner of the land to ensure that all site dimensions and measurements are accurate and any constraints such as easements or covenants are detailed.
- **19. PRIVACY SCREEN:** The privacy screen on the first floor balcony on the south-western side of the dwelling shall be extended the full length of that side of the balcony and a minimum height of 1.6m.
