	Maitland is one of the fastest growing inland cities in Australla, with the equivalent of a new family arriving every day. However, Council's current rating revenue covers less than half the cost of providing services to these new and existing residents.				
	Looking at growth and other factors, Council's well-tested financial model predicts an operational shortfall of \$92 million over the next ten years, if current services are to be maintained. Additionally, the community has told Council they would like some service areas improved OR enhanced.				
	In responding to the challenge, Council is proposing to increase total rating revenue by 8.35% per year for seven years, being a 58.45% cumulative increase (36.05% above the expected standard rate peg for the period). This increase would be retained permanently in the rate base after the seven years.				
	This would be done as a 'special rate variation', submitted to the Independent Pricing and Regulatory Tribunal for determination. Council's rating is spread across business, farmland, mining and residential categories. As this 8.35% per annum increase in total rates revenue is made, Council is proposing to shift the proportion of rating paid by each rating category, to ensure equitable distribution. Our average residential rating is comparatively low (S65 less than Newcastle and S155 less than Lake Macquarie), while average business and farmland are higher. This is the result of change, as farmland has been developed into residential housing, fewer farmland ratepayers have been left to pay the same proportion of rates. The shift proposed will address these issues. The average rate increase of each rating category would be as follows:				
	 Residential urban would have an average increase of 8.94%, or \$115 per annum, for seven years Farmland high intensity would have an average increase of 6.52%, or \$235 per annum, for seven years Business would have an average increase of 7.03% or \$458 per annum, for seven years. 				
	Under the proposal, all of Council's current services would be maintained as programmed, with enhancements in the following key areas to happen over the seven years:
