In accordance with Canterbury DCP 2012, the following application has been placed on public exhibition and can be inspected at our Customer Service Centre, Ground Floor, 137 Beamish Street, Campsie:

- DA-506/2013 an application for the refurbishment and reconfiguration of the existing Canterbury League Club including the construction of four level basement carpark and new loading dock at 26-62 Bridge Road Belmore. This application will be considered by the Joint Regional Planning Panel instead of Council. You may also inspect the application and plans at the Campsie Library, 14-28 Amy Street, Campsie.
