

Alinta AGN – Notice of Variation to Reference Tariffs

I refer to your letter of 22 May 2007, my response of 28 May 2007 and your subsequent advice that the Tribunal has confirmed its preliminary view that the inclusion of the holding cost for UAG variation is not consistent with Alinta AGN's approved Access Arrangement. Accordingly Alinta AGN submits an amended tariff variation to apply from 1 July 2007.

The proposed variations are a result of:

- the escalation of Reference Tariffs to allow for movements in the CPI Index for the period to December 2006, in accordance with section 3.11.1 of the Access Arrangement, and
- the variation between the allowance for UAG included in the cost of service for the Access Arrangement and the forecast UAG for the year ended June 2007, in accordance with section 3.11.2 of the Access Arrangement. This no longer includes the holding cost of the UAG cost variation.

In determining adjustments to Reference Tariffs the amount has been allocated to the Contract and Tariff Markets according to the same allocation methodology used in initially setting the Reference Tariffs. This is consistent with section 3.11.5 of the Access Arrangement.

- An Addendum to the Access Arrangement showing Tariffs in 2007/2008 dollars exclusive of GST.
- An Addendum to the Access Arrangement showing Tariffs in 2007/2008 dollars inclusive of GST.
