Subject: Plan to bury Sydney's overhead power cables

This Council strongly requests the Government of New South Wales to include the City of Blue Mountains in the Inquiry into the feasibility and cost of burying Sydney's overhead power lines.

Blue Mountains is a Metropolitan Council and an active member of the Western Sydney Regional Organisation of Councils (WSROC). In common with western Sydney, our electrical distribution network provider is Integral Energy. We would expect that there would be little difficulty in providing details of the Blue Mountains section of their network for inclusion in the Inquiry. Our communities suffer the same adverse effects of overhead power line failures as our neighbours in Sydney.

Our many small businesses **provide** much of the **local** employment **in** the Blue Mountains. **A reliable** power **supply is** essential, particularly for those providing holiday accommodation, tourism and catering facilities. Small businesses cannot afford an emergency power **plant** and their operations **are** severely damaged **by frequent** power and telephone failures during storms, lightning, bushfires, impacts with power **poles** and other events related to fallen overhead power lines.

It is known that the undergrounding of cables reduces transmission losses and maintenance costs. The Blue Mountains area regularly suffers severe storms and bushfires because of its topography. During emergencies such as bushfires the failure of electrically powered water **pumps** threatens efforts to **save** homes. Fallen power lines ate known to start bushfires and they create an electrocution hazard for children and the unwary. The community is well aware that residential and industrial development in the Blue Mountains has outgrown its ageing electrical infrastructure and it is imperative that it should be **updated** with the same urgency as that of **the** Sydney metropolitan area.

Apart from the legitimate expectations of residents and local businesses, the location of the City of Blue Mountains within a World Heritage National Park warrants early removal of old fashioned and environmentally unsightly power poles, pole-mounted transformers and aerial cables. Further, the regular and unsightly lopping of street trees emphasizes the presence of this aerial pollution. Views from Lookouts across the Jarnieson Valley in the high profile tourist areas of Katoomba and Leura are disgracefully marred by an array of aerial wires and poles at Echo Point and along the Cliff Drive.

Residents and Councillors strongly support this representation to the State Government for the City of Blue Mountains to be included in the Premier's Inquiry into the burying of overhead power cables. Your assurance of a positive response to this request would be very much appreciated.

A copy of this letter is being forwarded to the Member for Blue Mountains, the Hon Bob Debus and the Minister for Energy, the Hon Kim Yeadon.
