As per Part 3B of the Central Ranges Pipeline Gas Network (CRP Network) approved Access Arrangement, please be advised that Central Ranges Pipeline Pty Limited intends to vary the CRP Network 2006/07 Reference Tariff as per the following tariff escalation calculation:
