Cooranbong Water Pty Ltd application for a WIC Act licence variation

WHAT

Cooranbong Water Pty Ltd (Cooranbong Water) has applied for a *variation* to its network operator's licence number 15_033, granted under the *Water Industry Competition Act 2006* (NSW) (the WIC Act).

The application is to expand Cooranbong Water's current area of operations in order to provide drinking water, recycled water and sewerage services to the North Cooranbong Development and surrounding areas¹, in the City of Lake Macquarie local government area. Recycled water is proposed to be used for:

- toilet flushing
- washing machines (cold water)
- car washing
- ▼ irrigation
- ▼ water features, and
- dust suppression for construction activities within North Cooranbong.



WHERE

The proposed area of operations is within the Lake Macquarie Local Government Area and is identified on the attached map.



WHO

Cooranbong Water is the holder of the network operator's licence number 15_033.

HOW

This application is for a scheme which will collect sewage from homes businesses in an expanded area of operations. It will treat the water using its existing water recycling plant, located in Lot 12 DP 1158508. The recycled water produced by the plant will be distributed back to homes and businesses through a recycled water reticulation network which will be constructed, maintained and operated by Cooranbong Water. Recycled water will be of a quality that allows it to be used in homes and gardens, but not for Solids removed from the drinking. waterand sewage will be disposed off-site using an approved waste management contractor.

Cooranbong Water will continue to source drinking water from Hunter Water's drinking water network at the bulk supply point at Wainman Drive and deliver it to additional areas through an extended drinking water reticulation network maintained and operated by Cooranbong Water.

Cooranbong Water proposes to provide sewerage services to additional areas in the North Cooranbong development. Sewage will be collected and transported through an extended sewage reticulation network back to Cooranbong Water's water recycling plant.



WHEN

The submissions period is now open and will close on 12 December 2018.



WHY

A licence, if granted, would authorise Cooranbong Water and any nominated authorised persons to construct, maintain and operate water industry infrastructure for a certain purpose or to supply water or sewerage services, in the area specified. These activities cannot be undertaken without a licence.


