# Central Park Water Pty Ltd application to vary WIC Act network operator's licence (12\_022)



2 October 2019



### **WHAT**

We previously sought your feedback on an application by Central Park Water Pty Ltd (CPW) to vary its network operator's licence. CPW recently revised its application as follows:

- ▼ Amend the licence scope by broadening the licensed area of operations to include Jones St, Chippendale. CPW's initial request also sought to include the University of Technology (UTS) precinct.
- Amend the licence scope by allowing for the provision of recycled water in Jones St only. CPW's initial request sought to provide drinking water, recycled water and non-potable water services to the UTS precinct.
- Amend the authorised purposes for non-potable water to include:
  - ∀ Water features
  - General wash-down

  - Process water at the recycled water treatment plant.

CPW's initial request sought to add 'water features' and 'fire system top-up (via non-potable tanks)'.



#### WHY

A licence would authorise CPW and any nominated authorised persons to construct, operate and maintain licensed water industry infrastructure in the licensed area. These activities cannot be undertaken without a licence.



# **WHO**

CPW holds a network operator's licence (no. 12\_022) under the *Water Industry Competition Act 2006* (NSW) (WIC Act).

# **HOW**

CPW intends to supply recycled water from its treatment plant, located in the basement of One Central Park in the Central Park development, across Broadway and into Jones St. The treatment plant produces recycled water from two sources (sewage from the development and sewer mining from Sydney Water's system). CPW intends to supply recycled water to UTS via existing pipework.

The proposed area of operations is shown in the attached map.

The extended submission period is open now. We are accepting submissions on the revised application until 16 October 2019.
