Department of Primary Industries Fisheries IPART submission – 2017/18 to 2020/21 determination period

The Department of Primary Industries (DPI) Fisheries is responsible for the sustainable management of native fish species and their associated habitats throughout NSW. This outcome is achieved through ensuring all developments and activities within NSW are consistent with the objectives of the *Fisheries Management Act 1994* (herein referred to as the FM Act) and associated regulations. As the major bulk water provider across NSW, the activities and operations of WaterNSW intersect with the FM Act on a regular basis. This includes, but is not limited to, the provisions under Part 7 of the FM Act relating to the protection and restoration of fish habitats and the provision of adequate fish passage throughout the state's waterways.

DPI Fisheries has routinely provided advice direct to WaterNSW and IPART/ACCC with respect to the regulatory cost of compliance of WaterNSW activities. These costs represent the minimum investment required to ensure that WaterNSW operations are undertaken in a sustainable manner and are consistent with the legislative requirements as outlined in the FM Act.

The information enclosed with this letter summarises the estimated regulatory costs of compliance for the upcoming determination period. The submission includes a consideration of obligations to operate and maintain existing infrastructure in a manner consistent with the fish passage and dredging and reclamation requirements of the FM Act; the planning, design and environmental assessment costs associated with upcoming and completed capital expenditure, as part of works to ensure compliance with the FM Act and estimates of the capital expenditure themselves. The submission also considers the recent transfer of assets from DPI Water to WaterNSW and the associated regulatory costs relating to their ongoing management.

The current proposal for a Strategic Fish Passage Program for action at high priority fish passage barriers in NSW is noted in IPART's draft determination. The adoption of this program by the NSW Government, if supported, will not diminish the current legislative obligations of WaterNSW.

DPI Fisheries has considered the scope of works to be completed across the suite of WaterNSW assets relating to existing and future FM Act requirements and the feasibility of completing certain activities within the upcoming determination period.
