We wanted to express our strong objection to the unreasonable attack on the farmers of the Central coast region by Central Coast council in this proposal to charge us a large drainage fee (up to \$5,427.81 per annum).!! The management of this proposal also requires a proper review also.

There are ~~some~~ so many issues we will present them in point form:-

1. Persons with multiple titles will receive multiple charges even if the second title is an access issue.
2. The notification was received days after the initial closing date. No other warning of this price hike and the notice addressed to "the resident" !!
